### A BILL FOR AN ACT

RELATING TO DISORDERLY CONDUCT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the conveyance of
- 2 messages containing threats of violence, mass violence, or
- 3 destruction of property, using various media including the
- 4 internet, is a growing concern. These messages are often
- 5 intended as pranks, or are intended to disrupt services such as
- 6 the operations of educational facilities, and result in the
- 7 unnecessary expenditure of significant resources by law
- 8 enforcement agencies. Due to earlier court rulings, the Hawaii
- 9 Revised Statutes do not criminalize the making of false or
- 10 misleading threats.
- 11 Accordingly, the purpose of this Act is to amend the
- 12 offense of disorderly conduct to include engaging in conduct
- 13 with the intent to convey certain false or misleading
- 14 information.
- 15 SECTION 2. Section 711-1101, Hawaii Revised Statutes, is
- 16 amended by amending subsection (1) to read as follows:

Ţ	"(1)	A person commits the offense of disorderly conduct	
2	if, with	intent to cause physical inconvenience or alarm by a	
3	member or	members of the public, or recklessly creating a risk	
4	thereof, the person:		
5	(a)	Engages in fighting or threatening, or in violent or	
6		tumultuous behavior;	
7	(b)	Makes unreasonable noise;	
8	(c)	Subjects another person to offensively coarse behavior	
9		or abusive language which is likely to provoke a	
10		violent response;	
11	(d)	Creates a hazardous or physically offensive condition	
12		by any act which is not performed under any authorized	
13		license or permit; [ex]	
14	(e)	Impedes or obstructs, for the purpose of begging or	
15		soliciting alms, any person in any public place or in	
16		any place open to the public[-]; or	
17	<u>(f)</u>	Engages in any conduct with the intent to convey false	
18		or misleading information under circumstances in which	
19		the information:	
20		(i) May reasonably be believed; and

1	<u>(ii)</u>	Indicates that an activity has taken, is taking,
2		or will take place that could result in death,
3		bodily injury, or property damage, through the
4		use of a firearm or by widely dangerous means."
5	SECTION 3	. This Act does not affect rights and duties that
6	matured, penal	ties that were incurred, and proceedings that were
7	begun before i	ts effective date.
8	SECTION 4	. Statutory material to be repealed is bracketed
9	and stricken.	New statutory material is underscored.
10	SECTION 5	. This Act shall take effect upon its approval.
