# A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 304A-2007, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 4 expenditures in excess of appropriations. (a) The university
- 5 shall annually provide to the legislature, at least twenty days

- 4 (d) Beginning on January 1, 2010, the University of Hawaii
- 5 shall report semi-annually to the legislature on the moneys in

- 9 (e) The University of Hawaii shall submit an annual report
