
SENATE RESOLUTION

REQUESTING THE DRUG POLICY FORUM OF HAWAII TO STUDY HOW SOCIAL EQUITY HAS BEEN IMPLEMENTED IN THE CANNABIS INDUSTRY AROUND THE NATION AND WAYS SOCIAL EQUITY COULD BE IMPLEMENTED IN THE STATE OF HAWAII TO BENEFIT NATIVE HAWAIIANS AND OTHER VICTIMS OF THE WAR ON DRUGS, AND DIRECTING THE DEPARTMENT OF HEALTH'S OFFICE OF MEDICAL CANNABIS CONTROL AND REGULATION TO STUDY HOW TO INCLUDE THE EXISTING LEGAL GROWERS AND HEMP LICENSEES, INCLUDING NATIVE HAWAIIANS AND THOSE ON HAWAIIAN HOME LANDS, TO BE ELIGIBLE TO TEST AND SELL CANNABIS AND HEMP DIRECTLY TO OTHER PATIENTS, AND TO LICENSED DISPENSARIES.

1 WHEREAS, the current Hawaii medical cannabis dispensary
2 program system fails to provide a social equity framework,
3 through no fault of the current operators who are operating
4 under current rules designed in a previous era of cannabis law
5 and policy; and

7 WHEREAS, the war on drugs has been acknowledged throughout
8 the United States (see Michelle Alexander's seminal historical
9 analysis in her award-winning treatise, "The New Jim Crow"
10 republished 2020) and in Hawaii (see the 2010 Office of Hawaiian
11 Affairs report on "The Disparate Treatment of Native Hawaiians
12 in the Criminal Justice System") to have been and to still be a
13 racist campaign devastating and destroying immigrant,
14 indigenous, and low-income individuals, families, and
15 communities; and

17 WHEREAS, the mass incarceration that began with the war on
18 drugs, and includes cannabis prohibition, continues to
19 destabilize immigrant, indigenous, and low-income individuals,
20 families, and communities; and

22 WHEREAS, cannabis prohibition has deprived impacted
23 individuals' access to higher education, housing, and
24 employment, and of liberty, property, and the right to vote; and

1 WHEREAS, to counter the effects on individuals, families,
2 and communities, almost all state adult use and medical cannabis
3 legalization programs now contain or are built around social
4 equity considerations, including without limit, exclusive
5 licensing, technical assistance, and capital investment in
6 businesses owned by social equity qualified individuals; and

8 WHEREAS, while the term "social equity" in the cannabis
9 industry most often refers to the efforts to create an equitable
10 industry, social equity programs should encompass all pillars of
11 equity to ensure the efforts to redress the harms of cannabis
12 prohibition are as broad as the harms; now, therefore,

14 BE IT RESOLVED by the Senate of the Thirty-first
15 Legislature of the State of Hawaii, Regular Session of 2022,
16 that the Drug Policy Forum of Hawaii is requested to prepare, by
17 November 1, 2022, a comprehensive report on social equity
18 programs in the context of regulated adult use cannabis programs
19 in various U.S. state and local governments, including critiques
20 of these programs such as that of the Minority Cannabis Business
21 Association (MCBA) titled, "National Cannabis Equity Report
22 2022"; and

24 BE IT FURTHER RESOLVED that the report is requested to be
25 prepared in the style of a Legislative Reference Bureau report,
26 objectively providing options to the Legislature in a criteria
27 matrix format; and

29 BE IT FURTHER RESOLVED that the report is requested to
30 include consideration of exclusive licensing, technical
31 assistance, and capital investment in businesses owned by social
32 equity qualified individuals, and other elements of existing
33 social equity programs; producer/consumer cooperative models;
34 and automatic criminal record expungement for cannabis related
35 crimes in crafting an adult use regulated cannabis legalization
36 program within the larger context of adhering the benefits of
37 this new industry to Native Hawaiians and other victims of the
38 war on drugs, and potentially by requiring such businesses to
39 operate in the form of Sustainable Business Corporations with
40 specified public benefit goals and purposes and annual public
41 reporting requirements benchmarked to meeting minimal levels of



1 public benefit including social equity as a condition of
2 licensing; and

4 BE IT FURTHER RESOLVED that the Department of Health's
5 Office of Medical Cannabis Control and Regulation (OMCCR) is
6 requested to prepare, by November 1, 2022, a comprehensive
7 report on how to include the existing legal growers and hemp
8 licensees, under chapter 329, Hawaii Revised Statutes, including
9 Kanaka Maoli and those on Hawaiian Home Lands, as eligible to
10 test and sell cannabis and hemp directly to other patients, or
11 to licensed dispensaries; and

13 BE IT FURTHER RESOLVED that certified copies of this
14 Resolution be transmitted to the Governor, Attorney General,
15 Director of Health, Deputy Director of Health Resources
16 Administration, Chair of the Board of Trustees of the Office of
17 Hawaiian Affairs, and President of the Drug Policy Forum of
18 Hawaii.
