## SENATE RESOLUTION

DESIGNATING THE WAIANAE MOKU KUPUNA COUNCIL AS AN ADVISORY  
RESOURCE TO THE ELECTED MEMBERS OF THE LEGISLATURE OF THE  
STATE OF HAWAII REPRESENTING THE WAIANAE MOKU COMMUNITY.

1 WHEREAS, from time immemorial, kupuna have held respected  
2 and revered positions within Hawaii's households, families, and  
3 communities; and  
4

5 WHEREAS, kupuna today play an essential role in advising on  
6 appropriate actions that enable smooth and efficient  
7 relationships among members of households, families, businesses,  
8 and the community; and  
9

10 WHEREAS, the Waianae Moku community recently formed the  
11 Waianae Moku Kupuna Council comprised of kupuna who are sixty  
12 years of age or older and are long-time residents of Westside  
13 Oahu and Hawaiian cultural practitioners who possess historical  
14 and cultural knowledge about the Waianae Moku community; and  
15

16 WHEREAS, it is of great significance to the Waianae Moku  
17 community to have the Waianae Moku Kupuna Council be able to  
18 meet with elected officials representing the Waianae Moku  
19 community on a regular basis to provide, in the spirit of aloha  
20 and with humility, input on various issues that are of  
21 importance to the Waianae Moku community; and

23 WHEREAS, formal recognition of the Waianae Moku Kupuna  
24 Council as an advisory resource to elected members of the  
25 Legislature of the State of Hawaii who represent the Waianae  
26 Moku community is imperative to enable the Council to share its  
27 wisdom and advice on matters of importance to the Waianae Moku  
28 community; now, therefore,

30 BE IT RESOLVED by the Senate of the Thirty-first  
31 Legislature of the State of Hawaii, Regular Session of 2022,  
32 that the Waianae Moku Kupuna Council is designated by the  
33 Legislature of the State of Hawaii as an advisory resource to  
34 its elected members representing the Waianae Moku community; and
