"A BILL FOR AN ACT RELATING TO TRANSPORTATION NETWORK COMPANIES,"

beg leave to report as follows:

The purpose and intent of this measure is to:

- (1) Establish requirements and permitting procedures for transportation network companies operating in the State; and
- (2) Make permanent insurance requirements for transportation network companies and transportation network company drivers.

Your Committees received testimony in support of this measure from the Department of Transportation; Hawaii Insurers Council; Lyft; and Uber Technologies, Inc.

Your Committees find that statewide regulation of transportation network companies will ensure that residents and visitors have enhanced access to important transportation options, while also ensuring uniform consumer protection throughout the



State. Your Committees further find that making insurance requirements permanent for transportation network companies is appropriate and a continuation of protection for consumers.
