Your Committee on Ways and Means, to which was referred S.B. No. 1240 entitled:

"A BILL FOR AN ACT RELATING TO TAX CONFORMITY,"

begs leave to report as follows:

The purpose and intent of this measure is to require the State to conform to those provisions of the federal Consolidated Appropriations Act, 2021, relating to taxable income and deductible expenses.

Your Committee received testimony in support of this measure from Chamber of Commerce Hawaii; Hawaii Restaurant Association; Island Plastic Bags, Inc.; Hawaii Food Industry Association; Maui Chamber of Commerce; Hawaii Lodging and Tourism Association; Hawaii Association of Public Accountants; and one individual.

Your Committee received comments on this measure from the Department of Taxation and Tax Foundation of Hawaii.

Your Committee finds that the federal Paycheck Protection Program helped tens of thousands of businesses in the State to shoulder the economic downturn caused by the coronavirus disease 2019 (COVID-19) pandemic. Your Committee further finds that this measure will provide much-needed tax relief to small businesses that continue to struggle in the current economic climate, by allowing businesses to deduct, from their Hawaii taxes, those

payroll and other business expenses paid using Paycheck Protection Program loan proceeds.
