Your Committee on Judiciary & Hawaiian Affairs, to which was referred S.B. No. 2070, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SPECIAL PURPOSE REVENUE BONDS TO ASSIST THE HAWAIIAN LEGACY REFORESTATION INITIATIVE TO RESTORE HAWAII'S FORESTS AND NATURAL RESOURCES,"

begs leave to report as follows:

The purpose of this measure is to authorize the Department of Budget and Finance to issue special purpose revenue bonds to assist the Hawaiian Legacy Reforestation Initiative to generate a sustainable model of endemic reforestation, ecosystem revitalization, endangered species recovery, and carbon credit sequestering.

Your Committee received testimony in support of this measure from the Hawaiian Legacy Reforestation Initiative, Aloha Green LLC, HPM Building Supply, and eight individuals. Your Committee received testimony in opposition to this measure from 350Hawaii.org. Your Committee received comments on this measure from the Department of Budget and Finance.

Your Committee finds that native trees in Hawaii provide many benefits, such as reducing climate change, purifying the air, and providing habitats for wildlife. This measure authorizes the issuance of special purpose revenue bonds to support efforts to

further promote environmental protection, biodiversity, and climate change mitigation and restore the natural ecosystem in the State.


