Sir:

Your Committees on Commerce and Consumer Protection and  
Judiciary, to which was referred S.B. No. 2212, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO ROBOCALLS,"

beg leave to report as follows:

The purpose and intent of this measure is to hold  
telecommunication service providers and third-party spoofing  
providers accountable by making certain robocalls and spoofing  
unlawful.

Your Committees received testimony in support of this measure  
from the Department of Commerce and Consumer Affairs' Office of  
Consumer Protection, Maui County Office on Aging, Hawaiian Telcom,  
and one individual. Your Committees received testimony in  
opposition to this measure from CTIA and one individual. Your  
Committees received comments on this measure from the Department  
of the Attorney General and Department of Health.

Your Committees find that nearly sixty million Americans say  
that they have fallen victim to a phone scam in the past year.  
According to a survey conducted by TrueCaller and The Harris Poll,  
Americans have been swindled out of more than \$30 billion over the  
past year in total. Your Committees further find that this  
measure seeks to prohibit many of the same practices regulated by  
the federal Truth in Caller ID Act of 2009, Public Law 111-331,  
and provides another tool for state law enforcement to hold



telecommunication service providers and third-party spoofing providers accountable.

Your Committees have amended this measure by:

- (1) Inserting an effective date of July 1, 2050, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

As affirmed by the records of votes of the members of your Committees on Commerce and Consumer Protection and Judiciary that are attached to this report, your Committees are in accord with the intent and purpose of S.B. No. 2212, S.D. 1, as amended herein, and recommend that it pass Third Reading in the form attached hereto as S.B. No. 2212, S.D. 2.


