Sir:

Your Committee on Health, to which was referred S.B. No. 266
entitled:

"A BILL FOR AN ACT RELATING TO THE CORONAVIRUS 2019
PANDEMIC,"

begs leave to report as follows:

The purpose and intent of this measure is to appropriate
monies in order to assure sufficient resources to sustain and
enhance the State's coronavirus disease 2019 pandemic response.

Your Committee received testimony in support of this measure
from the Department of Health and Department of Human Services.

Your Committee finds that another bill, S.B. No. 1088, also
appropriate funds for response activities to the coronavirus 2019
disease and to provide transparency and accountability for the use
of those funds. Your Committee further finds that S.B. No. 1088
identifies specific purposes for which appropriated monies will be
spent.

Therefore, your Committee has amended this measure by:

- (1) Replacing its contents with the contents of S.B. No.
1088;
- (2) Inserting blank appropriation amounts;



- (3) Inserting an effective date of July 1, 2050, to encourage further discussion; and
- (4) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

As affirmed by the record of votes of the members of your Committee on Health that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 266, as amended herein, and recommends that it pass Second Reading in the form attached hereto as S.B. No. 266, S.D. 1, and be referred to your Committee on Ways and Means.


