Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 3298, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SHOOTING FACILITIES,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- Establish a working group to determine potential locations and requirements for a shooting facility on the island of Hawaii; and
- (2) Appropriate funds to establish a shooting facility in the County of Hawaii; provided that the County of Hawaii provides matching funds on a dollar-to-dollar basis.

Your Committee on Conference finds that the establishment of a multi-use public shooting range on the island of Hawaii is necessary

to provide a safe and organized facility to allow law enforcement agencies and the public to train and maintain their firearms skills. This measure will lay the foundation to provide a safe training area for the residents of the County of Hawaii by establishing a working group to determine potential locations and requirements for a shooting facility on the island of Hawaii.


Your Committee on Conference has amended this measure by:
