Sir:

Your Committee on Judiciary & Hawaiian Affairs, to which was referred S.C.R. No. 108, S.D. 1, H.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION AFFIRMING HAWAI'I'S ONGOING COMMITMENT TO THE GOALS OF THE PARIS CLIMATE AGREEMENT AND UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS AND ENDORSEMENT OF THE FOSSIL FUEL NON-PROLIFERATION TREATY,"

begs leave to report as follows:

The purpose of this measure is to affirm Hawaii's ongoing commitment to the goals of the Paris Climate Agreement and United Nations Sustainable Development Goals and Endorsement of the Fossil Fuel Non-Proliferation Treaty.

Your Committee received testimony in support of this measure from the Hawaii State Energy Office, County Council of Maui, Hawaii Institute for Human Rights, Stand.earth - Fossil Fuel Non-Proliferation Treaty and SAFE Cities, and three individuals. Your Committee received testimony in opposition of this measure from one individual.

Your Committee finds that the reliance on fossil fuels has resulted in the global climate crisis we find ourselves in today. Additionally, the construction of new fossil fuel infrastructure and expanded reliance do not reflect the coal, oil, and gas

omissions in respect to the supply and production. The overall reliance on fossil fuels expose communities to untenable risks to public health and safety at the local and global levels. Therefore, it is essential to commit to ambitious investments of lessening our reliance for the longevity of our world.


