begs leave to report as follows:

The purpose of this measure is to support the County of Hawai'i's efforts to pursue United States Army Corps of Engineers Continuing Authorities Program funding for the restoration of Kahalu'u Bay on Hawai'i Island.

Your Committee received testimony in support of this measure from the County of Hawai'i Department of Parks and Recreation, Friends of Hanauma Bay, Kahalu'u Bay Education Center, Hawai'i Reef and Ocean Coalition, Malama Pupukea Waimea, and two members of the Hawai'i County Council.

Your Committee finds that Kahulu'u Beach Park is a popular visitor destination, hosts diverse marine life, and is a culturally important site to native Hawaiians. Thus, it would benefit the State to protect the beach and bay from deterioration and damage caused by rising sea levels. Your Committee further finds that the United States Army Corps of Engineer's Continuing

Authorities Program can provide resources to facilitate the planning, design, and implementation of such projects.


