In accordance with the Court's directive of January 19, 1995, plaintiff, the United States of America, and the defendants, the State of Hawaii et al., hereby stipulate and agree to the following:

1) Beginning with the January, 1995, Monthly Status Report and all subsequent reports required by Part III of the Settlement Agreement entered in this case, the Defendants shall send to the

United States such reports by no later than the 15th of the following month.

2) The Compliance Officer required by ¶ 9 of the Stipulation and Order to Remedy Defendants' Contempt of the Settlement Agreement and Subject 12 of the Remedial Plan shall telefax reports to the United States on the status of the State's compliance with the terms of the Settlement Agreement and Remedial Plan by no later than the 22nd of each month, beginning on February 22, 1995. Should the 22nd of each month fall on a weekend or holiday, the Reports are due on the business day immediately preceding such date;

3) Beginning March 1, 1995, and on the first of every month thereafter, the United States shall submit written reports to the Court concerning the status of the State's compliance with the terms of the Settlement Agreement and Remedial Plan.


