SB 2721 Status & Testimony	RELATING TO ENERGY TAX. Subjects aviation fuel to the Environmental Response, Energy, and Food Security Tax. Effective 1/1/2023.	EET/TRS, WAM
SB 2196 Status & Testimony	RELATING TO ELECTRIC VEHICLE CHARGING STATIONS. Requires cooperative housing corporations, homeowners associations, planned community associations, and condominium associations to develop plans to integrate electric vehicle charging stations onto their properties and make funds available for that purpose. Requires electric vehicle charging station plans to be completed by January 1, 2030.	EET/TRS, CPN/WAM
