Amends the definition of the term "agriculture" as the term relates to the Agribusiness Development Corporation. Transfers the administrative attachment of the Agribusiness Development Corporation from the Department of Agriculture to the Department of Business, Economic Development, and Tourism. Amends the requirements and responsibilities of the Board of Directors of the Agribusiness Development Corporation. Amends the required contents of the Hawaii agribusiness plan. Appropriates moneys. Effective 7/1/2050. (HD1)
