HB 1494, HD1 (HSCR989-22) Status & Testimony	RELATING TO SPECIAL ENFORCEMENT SECTION. Amends the purpose and duties of the special enforcement section of the department of taxation. Effective 7/1/2050. (HD1)	GVO, WAM/JDC
HB 2007, HD2 (HSCR926-22) Status & Testimony	RELATING TO PROCUREMENT. Requires cash or protest bonds to be returned to the initiating parties, minus administrative costs, except in cases where the appeal was frivolous or made in bad faith. Effective 7/1/2112. (HD2)	GVO, JDC

- Testifiers for this hearing will be limited to **two minutes** each.
