RELATING TO LAND.

Authorizes the acquisition of real property located in Ewa Beach on the island of Oahu. Appropriates funds to the Hawaii housing finance and development corporation to purchase the fee simple interest or acquire an interest in the real property located in Ewa Beach on the island of Oahu to develop affordable housing, with priority given to department of education classroom teachers in the beginning of their career. Effective 7/1/2050. (HD1)
