RELATING TO HOMELESSNESS.

Authorizes the issuance of general obligation bonds for the development and construction of permanent supportive housing to address the needs of chronically homeless individuals and families and other vulnerable populations. Permits the Hawaii housing and finance development corporation to consider an application for any competitive federal low-income housing tax credits from the Hawaii public housing authority or partner, or both, for construction of permanent supportive housing units. Effective 7/1/2060. (HD2)
