<a href="#">SB 3186</a> <a href="#">Status &amp; Testimony</a>	PROPOSING AN AMENDMENT TO ARTICLE X, SECTION 6, OF THE HAWAII CONSTITUTION TO REPEAL THE UNIVERSITY OF HAWAII BOARD OF REGENTS CANDIDATE ADVISORY COUNCIL. Repeals the Candidate Advisory Council for the board of regents of the University of Hawaii. Authorizes the governor to appoint members to the board of regents of the University of Hawaii without being limited to selecting a candidate deemed qualified by the Council.	HRE, JDC/WAM
<a href="#">SB 3187</a> <a href="#">Status &amp; Testimony</a>	RELATING TO THE UNIVERSITY OF HAWAII BOARD OF REGENTS CANDIDATE ADVISORY COUNCIL. Eliminates the University of Hawaii Board of Regents Candidate Advisory Council. Authorizes the governor to directly appoint members to the University of Hawaii Board of Regents. Effective upon ratification of a Constitutional amendment.	HRE, JDC/WAM
<a href="#">SB 3354</a> <a href="#">Status &amp; Testimony</a>	PROPOSING AMENDMENTS TO THE HAWAII CONSTITUTION TO ESTABLISH A HAWAII COMMUNITY COLLEGE SYSTEM THAT IS SEPARATE FROM THE UNIVERSITY OF HAWAII. Proposes an amendment to the State Constitution to create a Hawaii Community College System to administer the State's community colleges. Provides for the Hawaii Community College System to be independent from the University of Hawaii and to be governed by an independent board of regents.	HRE, JDC/WAM

Requires the Board of Regents of the University of Hawaii to submit proposed legislation to establish a president of community colleges who shall be the head of the University of Hawaii community colleges and who shall report directly to the Board of Regents of the University of Hawaii. <a href="#"><u>SB 2304</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	<u>RELATING TO THE RESEARCH CORPORATION OF THE UNIVERSITY OF HAWAII.</u> <u>Clarifies that the purpose of the Research Corporation of the University of Hawaii is to promote educational, scientific, and literary pursuits through research, training of research personnel, and dissemination of knowledge by publication of research findings; and its undertakings shall be limited to acts that are reasonably necessary to carry out this purpose.</u>	HRE, WAM <b>[ADDED ON 02-03-22]</b>

<a href="#"><u>SB 3156</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	<u>RELATING TO THE UNIVERSITY OF HAWAII TUITION AND FEES SPECIAL FUND.</u> <u>To recognize the cost-sharing agreement for overall personnel expenses between State general funds and funds in the University of Hawaii Tuition and Fees Special Fund for appropriated general fund positions as beneficial to both the University of Hawaii and the State. Specifies conditions for exemptions for the University of Hawaii from sections 87A-39(a) and 88-125(a), Hawaii Revised Statutes.</u>	HRE, WAM <b>[ADDED ON 02-03-22]</b>
