Appropriates funds for the University of Hawaii Workforce Development Program for administration, training, positions, and student support.

RELATING TO ACADEMIC TENURE AT THE UNIVERSITY OF HAWAII. HRE, WAM  
Outlines tenure requirements and criteria for tenure-track faculty. Requires a minimum of at least one performance review every five years for tenured and tenure-track faculty. Requires a minimum of at least one performance review every three years for administrative, professional, and technical and non-tenurable employees. Established minimum faculty categories for all campuses. Establish a "C" classification for instructors at the community colleges. (Proposed SD1)
