Requires a sampling of medical records, rather than all medical records, to be reviewed when physician assistants prescribe controlled substances. Effective 7/1/2060. (HD2)	HTH, CPN/WAM

Sets the manner by which the Oahu regional health care system should request operational funding during the transitional period of the Oahu regional health care system from the Hawaii health systems corporation to the department of health. Extends the deadline by which the transfer shall take place. Requires a report to the legislature prior to the regular session of 2023. Clarifies the procedure for the working group to discuss matters concerning patient privacy and prospective bidders. Appropriates funds. Effective 7/1/2060. (HD2)	HTH, WAM
