RELATING TO CONSUMER PROTECTION.

TRS/PSM, JDC

In counties with a population of five hundred thousand or more, prohibits the sale of a bicycle that is reported as stolen and is listed on a publicly available online stolen item database and requires the county police department to establish the publicly available online stolen item database. Beginning 1/1/2024, updates the recordkeeping and retention requirements for businesses that buy previously owned articles. Effective 1/1/2023. (PROPOSED SD1)
