Look back at 2013 Legislative Achievements

Hawaii Growth Initiative *ACT 274* is a program that provides funding, incubation, and logistical support for small businesses that focus on bringing new technological advancements to the islands. This will generate new economic opportunities for all of the people of Hawai'i as well as their industries. This initiative promotes sustainability and progressive industries, grows our local economy and provides jobs for our communities.

Green Energy Market Securitization ACT 211 is an innovative new method of providing funds to middle and low income households interested in obtaining photovoltaic solar panels for their homes.

Kupuna Health Programs *ACT 214* Establishes and funds an Alzheimer's Disease and Dementia Services Coordinator, Kupuna Care Program, Aging and Disability Resource Centers, Senior Centers, and Healthy Aging Partnerships. It also appropriates funds for programs and services that support our Kupuna and established the Task Force on Mobility Management.

Homelessness ACT 222 Assists individuals facing or experiencing homelessness by funding various homeless and housing programs. Also provides substance abuse treatment and mental health support services. These programs are scheduled to start soon.

In preparation for the 2014 Legislative Session, Representative Justin Woodson was able to bring members of the House Committee on Finance to visit Maui to see firsthand some of the necessary funding needs for our community. The members were able to visit many sites on Maui. They were also given a personal tour of the University of Hawaii Maui College by *Chancellor Clyde Sakamoto*. The members were able to better understand the necessary operational funding needs for the campus.

The Finance members were also able to visit the Maui Film Studios where they met with CEO *Socrates Buenger* and Maui actor *Richmond Branscombe*. The film tax credit passed last session is already helping attract new potential film production to the island of Maui. This will mean good paying local jobs and a more diversified economy. This industry is estimated to bring in an additional \$200 million to our local Maui economy every year.

Rep. Woodson also took the members to Maui High School to see how desperately the students need a new wrestling, weightlifting, and band room facilities. Due to the tremendous success of the Maui High School Band in their many endeavors, the program has successfully increased in the number of musicians. This year Rep. Woodson will be fighting to accommodate this growth by providing funds to expand the existing band room at its current location, or building an entirely new band room, and will be negotiating funds for a new weightlifting and wrestling room for the school.

From the Desk of Representative Woodson

Representative Justin Woodson introduced the following measures that will improve education, health-care, environmental protections, energy costs, worker's wages, and benefits.

HB 2410 - In order to prepare Hawai'i's keiki for a prosperous and fulfilling future, it is imperative that we make sure our children can effectively compete with students around the world. HB2410 creates a pilot program to better support students, helping them to reach new internationally benchmarked standards. It also requires the Board of Education to provide web-based data to improve student outcomes and information aimed to provide more support for teachers.

HB 2411 - Modern advances in technology have made it possible for healthcare professionals to provide services for patients remotely over long distances. For families and individuals living with disabilities and or in remote areas, these new advancements in healthcare are extremely beneficial. In order to promote and sustain these programs HB2411 promotes proper market value reimbursement for services provided through the telehealth program to be equivalent to reimbursement for the same services provided via face-to-face contact between health care providers and patients.

HB 2412 - We have a responsibility to care for and protect our aina in order to foster a healthy and vibrant Hawai'i for the future. HB2412 establishes environmental courts as a separate division within the circuit court to hear all cases arising from environmental laws. This bill will stream-line the court process for environmental cases and issues.

HB 2413 - In order to help Hawai'i's working families HB2413 expands the current prevailing wage law to all labor related public-private partnerships. This bill will promote fairness, safety and higher wages for all workers involved with public-private partnerships within the construction industries.

Additional Legislative Priorities

HB 745 - It is crucial for parents to be involved in their child's education, but sometimes work can interfere. This measure will authorizes family school leave (provided certain requirements are met) so that working families may participate in their children's school activities. This will prohibit employers from discharging or otherwise discriminating against an employee for taking family school leave.

HB 916 - The time is now to help our minimum wage workers, but wages must increase responsibly so that small businesses, the job providers, are not harmed. This bill gradually increases the minimum wage over a period of several years, promoting a higher standard of living for minimum wage earners.

HB 1752 - This bill funds to provide primary medical, dental, and behavioral healthcare to uninsured and underinsured patients and restores basic adult dental benefits to medicaid enrollees. It also appropriates moneys to community health centers to provide outreach and eligibility services as well as behavioral services and establishes health care homes for medicaid enrollees.

HB 2053 - Establishes a fall prevention and early detection coordinator within the Department of Health's Emergency Medical Services and Injury Prevention Branch.
