### ALOHA, FRIENDS & NEIGHBORS!

Following a month of alarming increases in COVID cases, we're back on lockdown till September 9. According to the Mayor and the Governor, the intent of this <u>Order</u> is to curb the rapid spread of the COVID-19 virus and to protect our community's most vulnerable as well as our healthcare providers. I believe this lockdown could have been avoided if the Department of Health (DOH) had implemented their contact tracers' plan they assured us they were working on over the last 4 months.

Governor Ige and Mayor Caldwell also announced a number of other developments to address the pandemic and its economic impact, among them:

- The federal government will be providing 60,000 COVID tests during the next couple of weeks.
- After vetoing the \$100 plus up unemployment benefits, and no Congressional action on extending unemployment insurance relief, the Governor has finally applied for the \$300 weekly unemployment benefits provided through the Federal Emergency Management Agency.

Meanwhile, the Senate Special Committee on COVID-19, of which I am a member, has continued to meet to oversee the state government's responses to the crisis. Here's what we learned:

### Department of Human Resources Development

- We were troubled to hear from state workers that health and safety protocols are not applied consistently among state agencies. Many state offices are not social distancing and wearing masks.
- The Department has a telework program dating back to 2010 that is being used as a template. The program has guidelines for teleworking, but the department director said his agency is leaving implementation to each agency.
- All state employees are considered critical infrastructure workers and are not subject to the mayors' orders, only the governor's directives.
- The committee has requested that departments inform their employees of teleworking requirements and how they are implementing social distancing to keep their staff safe.

### Hawaii Emergency Management Agency (HIEMA) and Department of Defense

• We learned that Maj. Gen. Hara is back in charge as Incident Commander and that he and the National Guardsmen are helping DOH with investigations and contact tracing, formulating operational and organizational plans, and training requirements. They are also assisting hospitals in increasing capacity so intensive care and respirator capacity are available, as well as looking for alternate care facilities if hospitals reach capacity. They are available to help Public Safety with the prisons if needed.

### Department of Health

- The committee's visit to the DOH on August 7 exposed the truth, that we do not have enough contact tracers—as we suspected—despite what Health officials have said publicly, and that the ones we do have are overwhelmed by the increasing number of cases.
- We toured the Convention Center and met with Maj. Gen. Hara and Dr. Emily Roberson, head of the contact tracing program, to get a first-hand account of the state's new expanded office for contact tracing. At the insistence of the committee members, the Convention Center was set up to increase the state's ability to

contact trace every positive case discovered in the islands within 24 hours. We were happy to see how they were able to scale up this process in the last 2 weeks. Just think where we would have been had they exercised this urgency one to two months ago.



Kymberly Sparlin, the Governor's Director of Intergovernmental Relations and Policy, accompanied the committee during their site visit to the Convention Center.

The committee will continue to follow up with airports to ensure that we will be ready when the Governor opens Hawaii to interstate/international travelers, public schools, unemployment, law enforcement and public safety officials.

### Women's Equality Day - August 26

In other matters, this year marks the centennial of women's suffrage, which gave women the right to vote through the 19th Amendment to the Constitution.

I introduced a resolution this year, Senate Resolution 52, and the governor issued a proclamation calling for August 26 to be observed as "Women's Equality Day." The resolution cites and celebrates the many contributions women have made to the nation and Hawaii, particularly as decision-makers who influenced and shaped the Hawaiian Islands' growth from kingdom, to territory, to state.

## HAWAII APPLIES FOR UNEMPLOYMENT BONUS PROGRAM

Gov. Ige and Department of Labor and Industrial Relation (DLIR) Acting Director Anne Eustaquio announced that Hawaii will apply to participate in a new unemployment insurance plus up program called the Lost Wages Assistance (LWA) Program. The program, under the Federal Emergency Management Agency (FEMA), was created by the president via a <u>memorandum</u> earlier this month in response to the July expiration of the unemployment \$600 weekly benefit.



Upon approval, Hawaii will offer an additional unemployment compensation benefit of \$300 per week to eligible unemployment recipients. To qualify for this benefit, recipients must be eligible for at least \$100 in weekly benefit and must certify that they are unemployed or partially unemployed due to the disruptions caused by COVID-19. Payments would be retroactive to August 1, 2020.

Unlike the program that ended in July, LWA is a grant with a finite amount of funding, up to \$44 billion from the Department of Homeland Security's Disaster Relief Fund. The program will end once that money is spent. It is also only eligible for weeks of unemployment ending

no later than Dec. 6.

DLIR is preparing for applications in anticipation of the state's approval into the program. When FEMA exhausts its grant funding, it will no longer have the resources to provide LWA payments and the program will end. If the federal program does not exhaust the LWA grant funding, payments will end on Dec. 26, 2020.

Claimants who are unemployed or partially unemployed due to COVID-19 and are eligible to receive at least \$100 per week in unemployment benefits from one of the following programs will be eligible to receive \$300 a week in LWA funds from FEMA:

- Unemployment Insurance (UI)
- Unemployment Compensation for Federal Employees (UCFE)
- Unemployment Compensation for Ex-Servicemembers (UCX)
- Pandemic Emergency Unemployment Compensation (PEUC)
- Pandemic Unemployment Assistance (PUA)
- Extended Benefits (EB)
- Trade Readjustment Allowances (TRA)

# NEW SITE TO OFFER RESOURCES TO THE COMMUNITY



On Wednesday, August 26, the Hawaii Emergency Management Agency (HIEMA) announced the establishment of a portal for businesses, organizations and residents to offer resources to the community to help Hawaii respond to the current or future needs of the ongoing COVID-19 pandemic. The <u>Kokua Offers</u> portal replaces the Governor's CovidKokua@hawaii.gov email address previously utilized to solicit assistance, which allowed 473 companies, organizations and Hawaii resident to offer COVID-specific resources and ideas some of which were adopted.

Additionally, HI-EMA has launched a website for independent medical and dental practices, small groups, small hospitals, small businesses, and non-profits to obtain free personal

protective equipment (PPE). There are 12 items available and there is a prioritization list of which organizations have access to which supplies and how many. While it takes 2-3 months to receive bulk orders, each organization will be sent supplies that are already on island while they wait for what they ordered.

# HECO MORATORIUM ON DISCONNECTIONS EXTENDED TO DECEMBER 31

Hawaiian Electric has extended the moratorium on disconnections of electric utilities to December 31, 2020. The Public Utilities Commission (PUC) ordered that all regulated utilities extend their moratoriums, and reminded customers to pay "their bills to the extent possible during this time, noting that customers will still ultimately be responsible for paying Utility service billings accrued during this suspension."

Hawaiian Electric encourages customers that need assistance and qualify to seek utility bill assistance from government and non-profit resources as needed to ensure their bill payments are manageable. # SATELLITE CITY HALLS & DRIVER LICENSING CENTERS CLOSE TO IN-PERSON SERVICES

The city's Department of Customer Services will be suspending for two weeks all face-to-face visits to its offices on Oahu, beginning Thursday, Aug. 27.

The suspension includes in-person transactions at driver licensing centers and satellite city halls.



The temporary closure complies with Mayor Kirk Caldwell's emergency stay-at-home, work-at-home orders that will remain in effect through Wednesday, Sept. 9 to help curb the spread of the coronavirus.

Only appointments during the two-week closure period will be canceled. Efforts will be made to reschedule those affected as a priority. Appointments will be honored after the orders are lifted as scheduled.

Department staff will continue to process online and mail-in applications, payments as well as perform other administrative functions.
