2014 CORNERSTONE LEGISLATION

SB2561 "Relating to Cottage Foods"

States across the nation have been empowering potential small business owners by relaxing restrictions on cottage food operations, and it is high time that Hawai'i follows suit. The current laws restricting homebased food businesses unfairly stem the flow of quality, locally-grown products from farmers, bakers, and chefs to the consumers who want to support them.

The bill, which Sen. Ruderman introduced as part of our Local Food Caucus Package, allows home-based food businesses to either sell directly to their customers (as a Class A cottage food operation), or disburse products through a third party retailer (as a Class B cottage food operation). This bill will foster positive economic growth and support the local food movement, as has happened in other states through similar legislation. SENATOR LAUNCHES NEW LOCAL FOOD CAUCUS !

This year, Senator Ruderman launched the Hawai'i State Legislature's Local Food Caucus with Representative Chris Lee and Representative Nicole Lowen, which brought public, private, and nonprofit stakeholders together in the Capitol to develop strategies for promoting local food production.

At the inaugural meeting, attendees gathered valuable input regarding issues of importance to the local food industry, which was utilized to select the bills included in the Local Food Caucus' 2014 legislative packet. These efforts culminated in the introduction of 15 bills, covering issues from cottage food operations, to invasive species management, to industrial hemp legalization, and more.

Many of these bills were introduced simultaneously in both the House and Senate (as "companion bills") in order to expedite their passing.

The Local Food Caucus greatly benefitted from the contributions and insights from private and nonprofit organizations and enjoyed broad support within the Legislature. We would especially like to thank the 33 Senators and Representatives who joined the Local Food Caucus, and helped propose and introduce legislation on behalf of the Caucus. Supporters look forward to seeing how this package of legislation can positively impact and further the local food industry in Hawai'i!

A Thousand Local Businesses." With Hawai'i's plentiful bounty of produce at hand, the possibilities for cottage food operations are endless; we must see to it that this bill is passed.

Minimum Wage Increases

Sen. Ruderman fully supports an increase in the minimum wage. Even as an employer, I realize that the benefits of a higher minimum wage outweigh any negative effects. In our world, and especially in a state with such a costly standard of living as Hawai'i, it's incredibly difficult to make ends meet on minimum wage.

Many bills proposing a minimum wage increase were introduced this year, one of which was Sen. Ruderman's bill, SB2641. However, constituents are encouraged to support a parallel bill, SB2609, This bill provides gradual minimum wage increases and would allow for yearly increases based on the local consumer price index. Last but not least, it would repeal the tip credit, which has allowed employers in tip-producing industries to vastly underpay their workers for far too long.

SB2645 "Relating to Industrial Hemp"

This bill will not only facilitate a legal hemp industry by establishing the necessary authority, procedures, and licensing, but it will also foster growth within this new industry by requiring the Department of Agriculture to promote industrial hemp research and market development. Hemp has many practical uses, including but not limited to nutritional and food products, building materials, clothing, and biofuel. The agricultural, economic, and environmental benefits of legalizing industrial hemp far outweigh any concerns regarding its correlation to a certain illicit substance.

SB2644 and SB3067 Funding Requests

For the underserved Puna community, Sen. Ruderman has requested funding for additional emergency medical services - SB2644, as well as an exploratory study to determine the feasibility of building a new regional community library, SB3067. As always, constituents are encouraged to contact Senator Ruderman's office with any other concerns or requests from constituents regarding District 2. Δ

TIPS FOR EFFECTIVE PARTICIPATION IN THE LEGISLATIVE PROCESS

Participating in government can be intimidating. Unless you happen to work with or in the government, many of us haven't thought about the legislative process since studying the US Constitution in high school. People hold the power, but some of us become overwhelmed, disappointed, and apathetic about actually participating because of our own personal or cultural reasons. Hopefully the following tips regarding the legislative process will inspire you to participate in our democracy!

• Visit the Public Access Room in the Hawai'i State Capitol, Room 401. They can provide you with a wealth of information about the legislative process. Here they can support people who would like to introduce their own bills and teach how to track bills. You can also use this space (for legislative purposes only) to submit testimony, organize groups, and learn timesaving tips.

• Prewrite testimony on a heading so that you can submit them ON TIME. Register on the Hawai'i State Legislature webpage and use the tools available to track the bills that matter most to you and submit testimony before the hearing. For a bill to be passed, it has to be heard at committee hearings. If your bill is not being heard, take the time to individually contact each member of the first committee it is assigned to and your representative.

•Whether you support or oppose a bill, contact your representative by email or phone. In the email subject, write if you are a constituent (if not, there is no need to add that information in the subject), the bill number, and whether you stand in support or opposition.

• Be respectful always. If you are really angry about an issue, go ahead and write a wildly angry email, let it all out...then trash it. The emails that are most effective are respectful from start to finish. emails include links to studies, articles, or bills that have passed in other states that support your cause.

• Be creative about how you advocate. For example, if you would like to see the SB2561 Relating to Cottage Foods to be heard, bring your homemade baked goods to the health committee members as an example and tell them about the jobs you could create by being able to sell these goods from your home.

• Incorporate our youth! Nothing melts hearts faster than watching a child give testimony on a bill that will directly affect them. Our young adults have a powerful voice too and draw attention.

• Set priorities and keep your messaging consistent. If you become attached to too many bills you may lose your focus and your mind while trying to keep up with the tracking process.

• Most importantly, for your own health and well-being, keep your message positive. If you are constantly on the "anti" side of the argument without promoting, researching, and participating in viable solutions, you will burn out. There is definitely a time and a place for protest but be sure to also explore and share solutions and innovative ideas.
