Future Flight Hawaii celebrated 20 years of supporting, encouraging participation and learning through various science, technology and space programs and bringing space travel to life for our students.

Future Flight Hawaii was initiated by the Office of Space Industry, Hawaii Department of Business, Economic Development and Tourism. Since1996, the Hawaii Space Grant Consortium at the University of Hawaii has managed Future Flight Hawaii.

Over the years, Future Flight Hawaii has had over 8,500 students and parents participate in various exploration programs on the Big Island, Maui, Kauai and Oahu. Over 175 teachers statewide have been on the Future Flight Mission Control Team, which develops and delivers engaging and relevant hands on lessons in science and technology to the classrooms throughout Hawaii. The Future Flight Hawaii outreach program has been presented to over 150,000 children, parents and teachers throughout Hawaii, including family science nights and classroom, assembly and community programs.

The issue of **resurfacing the section of Mahiole Street** (from Moanalua Middle School to Jarrett White Road) was brought to our attention.

Our office contacted the State Department of Transportation (DOT) Director Brennon Morioka to inquire about the status of resurfacing, as well as to inquire if this section, and other similar parcels, could be transferred to the City and County of Honolulu so that they do not get overlooked in the future.

Brennon Morioka responded that normally the City and County of Honolulu coordinates with the State for some of these resurfacing efforts. Unfortunately, this was not the case for this project. The State is hoping to resurface this small portion of Mahiole by this summer or early fall.

DOT Director Morioka also stated that there are various reasons why portions of intersections should remain under State DOT jurisdiction.
