# **2008 Legislative Highlights**

At the beginning of the 2008 session, about 2,748 bills were introduced covering a range of issues and subject matters. After four months of public hearings, many amendments and numerous votes, 294 measures were approved at the close of the session and passed to the Governor for approval or veto. The Governor vetoed 58 bills and the Legislature overrode 14 of them. The following represents some of the highlights of the 2008 legislative session.

#### **Sustainability**

Sustainability is on the minds of all in the state. Senators participated in a pilot "paperless" effort, reducing their consumption by millions of pages. As a result, all public documents are now available online at:

The Legislature also sponsored many sustainability initiatives:

 New requirement to recycle electronic device waste manufacturers will now be required to collect and recycle computers and other electronic devices.

#### **VETOED & OVERRIDEN**

- Expansion of the state's **biosecurity** program, increasing protection from new importation of invasive species.
- Prohibition on the sale of noxious weeds.
- New tax credits to encourage renewable energy and land conservation.
- A pilot food waste recycling program in public schools. VETOED & OVERRIDEN
- New incentives to preserve important agricultural lands and operations.
- New staff positions within the Department of Business, Economic Development and Tourism to ensure that the state's Greenhouse Gas Task Force meets its goal of reducing Hawaii's emissions by 2020.
- Solar water heating systems on all new homes starting in 2010.

#### **Education**

The 2008 Legislature aimed to support and improve Hawaii's education system from prekindergarten through college:

- Address the teacher shortage by providing funding for tutorials and preparation for PRAXIS examinations. VETOED
- Lifting the one-year restriction on participation in the Bridge to Hope vocational education program to increase participants' economic self-sufficiency.
- Launching of a new statewide early learning preschool system.
  VETOED & OVERRIDEN
- Funding of \$173.3 million for repair and maintenance and new construction on all UH campuses.
- Funding of \$310 million for repair and maintenance and new construction of K-12 facilities statewide.

# And Accomplishments

#### **Transportation**

- \$124 million in funding for harbor modernization improvements statewide.
- Requiring ignition interlock devices to prevent past DUI offenders from operating their vehicles.
- Making it a violation to leave a child under the age of nine unattended in a motor vehicle.

#### **Procurement**

### The Senate decided that current practices should be reviewed and reformed because of

numerous incidents calling into question the procurement practices of several departments and agencies. It created a special committee this session to investigate the state's award of an \$8.7 million contract for renewable energy last year and concluded that the award did not conform to procurement laws. As a result, the Legislature reviewed and passed several new initiatives intended to ensure more accountability in future procurement practices:

- Fines for state procurement officers who do not take corrective action within 30 days.
- Requirements to ensure **timely posting** of information regarding state contract awards.
- Annual **random audits** of purchasing agencies, as well as audits of agencies that show a history of noncompliance.
- Mandatory training for state procurement officers and follow-up training thereafter.

#### Change For The Better

Other notable initiatives that passed in the 2008 session:

- Increased funding to enhance the state's **Kupuna Care** program, which helps our elders to live as independently as possible.
- A new Small Business Bill of Rights.
- More support for the Cancer Research Center of Hawaii.
- Plan to provide facilities and services for returning Hawaii's female prisoners from mainland institutions.

- A working group to begin work on establishing the Hawaii Health Corps program to provide loan repayments for physicians and dentists who agree to practice in rural or medically underserved areas in the state.
- Reporters will be protected from having to disclose their sources or unpublished information.

# **School Improvements**

Most of these projects were on the DOE priority list for FY07-08. They are still the current projects on the DOE priority list for FY08-09 because the money has not been released. Projects with no \$ amount listed are projected to cost less than \$100,000, \*\* indicates CIP, and ++ indicates appropriations made in previous years and are currently a work-inprogress.

# **District Update and Recognition**

#### Puuloa Road Improvements Project

The state broke ground on this project in 2005 with an initial completion date of summer 2007. Due to unanticipated underground utility lines and rains, the project has been delayed. Projected completion is tentatively set for November 2008.

This **\$15.8 million revitalization project** will include, turn lanes, bike lanes, drainage system, landscaping, lights, a sidewalk and a **90 stall parking lot.** 

Currently, the contractor has completed installing major portions of the new drainage system and installation of the fire hydrants. The new traffic signal system at the Puuloa-Pukoloa and Salt Lake Boulevard intersection has been activated and is in operation. Additional adjustments to the traffic control system and activation of the traffic camera systems will occur shortly.

Work on the construction of the grade adjustment walls, excavation of the roadway (east side), installation of the highway system, new curb and gutters have begun.

Work to be completed include removal of the existing overhead utility lines, wooden poles, construction of the parking lot, final roadway resurfacing and landscaping.

## **District Survey**

Our most challenging issue before us is the slowing economy. At current levels of Revenue and Expenditure, our state was projected to spend **\$239 million** more than we received for the year ending 7/31/08. For the current fiscal year ending 7/31/09 we are projected to spend **\$162 million** more than we will receive. Current budget cuts and restricted spending reduce that amount.

It is important to voice our thoughts and opinions about how government works for us. We need to reduce what government is currently providing or we need to find ways to pay for those services.
