LEGISLATIVE UPDATE 2010

I'm honored and privileged to say MAHALO for allowing me to work with you to improve our schools, our community and our state for the past fourteen years.

The Legislature provided the funding to solve the furlough problem for our schools in our recently concluded session. The Governor, the Superintendent of Education, the Board of Education and Legislature did our part. It took Don Horner of First Hawaiian Bank to finally break the costly deadlock. I am glad it's over - and in time for it to positively impact Hawaii's 'Race to the Top' application for federal funding. In addition to funding Furlough Fridays, we passed legislation increasing the amount of instructional time in Hawaii public schools up to the national average. Increasing instructional time will provide more opportunities for excellence in education.

Over the years, other accomplishments that were possible through collaborative leadership include: the reduction of repair and maintenance backlog to its lowest level in ten years, a unified school schedule, and providing more dollars directly to schools and principals. We can make great improvements in our children's education and in their future if we work together. Our keiki will thrive when we all pull in the same direction.

2010 LEGISLATIVE HIGHLIGHTS

The following list represents some highlights of the 2010 legislative session:

Priorities

The Legislature achieved \$324 million in savings over last year's 2010-2011 budget by:

- Taking many of the governor's proposed vacancy reductions and reductions in force
- Reducing \$500,000 in overtime and \$900,000 for legislatively initiated but unimplemented programs in the **Department of Public Safety**
- Reducing **Department of Health** Purchase of Service contracts by 5% totaling \$5.4 million
- Reducing Department of Human Services Purchase of Services contracts by 5% of budgeted amounts, totaling \$2.4 million.

At the same time, we maintained funding for education, health & human services, and our agricultural industries. We are particularly proud that we were able to restore all of the funding for public libraries that the governor cut from her budget proposal. That's \$3 million to help ensure that the public will continue to have access to library services.

In other adjustments, the legislative budget did the following:

- Reallocated funding for categorical programs for the weighted student formula, \$22.6 million, providing a minimum of \$113 per student.
- Restored and increased funding for defense, including financial, cemetery and staff positions to those who provide services to those who served our country.
- In education, the budget maintained funding and ensured that charter schools (with their projected 19.4% enrollment increase) will have general fund support comparable to non-charter school students by adding \$5.3 million.
- Preserved health services by adding

\$4.5 million in general funds to emergency medical services; \$2 million in special funds to community health centers; and \$300,000 in general funds to the disability and communications access board.

- Restored 440 positions (247 general funded) and \$5.5 million in general funds for Human Services programs.
- Served our agricultural industries with 45 general funded positions (half are plant quarantine inspectors) and \$2 million in general funds.

Closing the Gap

The legislature took the position that closing the budget gap would require taking small amounts from a number of sources to prevent any one segment of the community from bearing an unfair burden. Overall budget reductions from the biennium budget we passed last year totaled \$783.6 million, or 53% of the total budget shortfall. The legislature took a number of actions that, while small individually, combined to close the gap.



**Through accounting adjustments, including a requirement to take refundable tax credits before non-refundable credits, and changing the tax payment due date, we increased revenues by \$168.5 million, or 12% of the

**Increasing enforcement of tax provisions and GET trust liability generated \$27.1 million, or 2%.

**Deferring tax refunds to FY 2010-2011 contributed \$275 million (19%).

**Small tax increases including the cigarette and barrel taxes. combined with changes to itemized deductions added \$57.4 million (4%).

Plan to End Friday Furloughs

The agreement was made possible by a partnership between the State, teachers and the major banks in Hawaii. The plan calls for:

- \$57.2 million from the Hurricane Relief Fund
- \$2.2 million in federal funds for charter schools
- 6 planning days the teachers have given up in order to convert them into instructional days
- \$10 million interest free line of credit from local banks if additional funding is necessary

Homeless Assistance

(HB 2318)

Establishes a special fund for Housing First programs and special services that would assist chronically homeless individuals.

Unemployment insurance (HB 2169)

Reduces a pending increase in unemployment taxes for businesses by about half. The average tax per employee would be \$630, not \$1070 as expected. The average tax per employee last year was \$90, but was set to increase because of rising unemployment and the depletion of the unemployment trust fund.

Gambling Losses

(SB 2834) Allows gambling losses to be deducted from winnings for income tax purposes.
