Department's Position:

The Hawaii State Department of Education (Department) supports HB 1864, HD1. The Department appreciates this proposal and the inclusion of funding but asks that any additional funding does not affect the Department's top budget priorities to restore funds that were reduced as a result of the fiscal fallout from COVID-19 and the funding of existing budget shortfalls that were included in the Department's supplemental budget request. Without those funds, the Department will face severe constraints on its ability to continue to promote equity and access to needed resources and support for all

students.

The funding for maintenance and upgrades of school kitchens and cafeteria staff training in the areas of scratch cooking, recipe development and standardization, just-in-time food preparation, waste management, and record keeping will be highly beneficial for the 194 production kitchens and 62 serving kitchens in the Department.

The Department seeks to clarify with the Department of Budget and Finance what equipment, if any, can be purchased using general obligation bond funds. Our understanding is that some general funds may be needed for the assessment of school kitchens and to purchase equipment.

The additional funding will support the farm-to-school program and assist the Department with fulfilling the goals of Acts 175 and 176, Session Laws of Hawaii 2021.

RELATING TO SCHOOL FOOD PROGRAMS

The Department of Budget and Finance (B&F) offers comments on House Bill (H.B.) No. 1864, H.D. 1.

H.B. No. 1864, H.D. 1, appropriates \$29,000,000 in general obligation bond funds in FY 23 for school cafeteria upgrades and \$4,000,000 in general funds in FY 23 for cafeteria staff training to improve the ability of the Department of Education's school food programs to serve students fresh, locally-grown foods.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

We are a Hawaiʻi-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food; renewable energy and clean transportation; and better management of freshwater and waste.

Ulupono <u>supports</u> **HB 1864 HD 1**, which appropriates funds for school cafeteria upgrades and cafeteria staff training to improve the ability of the Department of Education's school food programs to serve students fresh, locally grown foods.

Ulupono supports the DOE's efforts to move the Hawai'i Farm-to-School Program's local food procurement forward with impactful resource dedication. We are supportive of increasing staff training for scratch cooking and local food purchasing as mentioned by the DOE's Act 175, SLH 2021 Report to the Legislature. In that same report, the DOE mentions the lack of a centralized data system and internal controls. Ulupono believes that it is of extreme importance that the DOE prioritize this centralized data system to better understand how funds are currently spent and improve internal decisions around increasing local food purchases for schools statewide. This system has the ability to support DOE's future strategy to incrementally increase local sourcing for school meals. We ask this committee to consider adding an appropriation for the DOE's centralized data system as mentioned in their Act 175, SLH 2021 report and set a deadline to implement such a system.

On behalf of the Hawai'i Farm to School Hui, thank you for the opportunity to testify in **support of HB1864 HD1**, which appropriates funds for school cafeteria upgrades and cafeteria staff training to improve the ability of the Department of Education's (HIDOE) school food programs to serve students fresh, locally grown foods.

School cafeteria upgrades and cafeteria staff training have long been recognized as critical action points for successfully and equitably advancing farm to school efforts across HIDOE. The 'Aina Pono Hawai'i State Farm to School Report on the piloting of farm to school meals that occurred in Kohala and Mililani between August 2016 through July 2018 states: "Currently, School Food Services Branch training for school cafeteria workers is not sufficient, and training needs will increase with a scratch cooking program." The report recommends creating a "strategic year-round training program" to include measuring overproduction, working as a team, proficiency with knife skills, and other areas as shown on page 67.

From April through June 2020, all public school kitchens on the island of Kaua'i were assessed for the purposes of preparing for farm to school meal implementation there. HB1864 HD1 fulfills the initial next step recommended within the <u>Farm to State</u>: <u>Island of Kaua'i Report</u>, which is to "secure funding for equipment for kitchens and upgrades" (page 86). Importantly, both reports also recommend there be one supervisor present full time within each district and visiting schools regularly to provide ongoing training and support (pages 67 and 80, respectively).

The **Hawai'i Farm to School Hui** is a statewide network comprising five Island Networks and over forty public-private entities with a collective mission to strengthen Hawaii's farm to school movement. The three pillars of successful farm to school programs are: 1) school gardens and on-campus farms, 2) food education, and 3) school food improvements through local procurement. The Hui formed in 2010 and is a program of Hawai'i Public Health Institute.

The Hawai'i Farm to School Hui appreciates this Committee's strong support of farm to school, and respectfully requests that the Committee continue this support by passing HB1864 HD1.

Dear Chair Woodson, Vice Chair Kapela and members of the Committee,

The Hawai'i 'Ulu Producers Cooperative supports HB 1864 Relating to School Food Programs. We formed the Hawai'i 'Ulu Cooperative in 2016 to build a network of small-scale, diversified farms that grow breadfruit and want to improve community access to this amazing, nutritious food. From 2018 to 2020 we were a primary local supplier for the DOE's 'Aina Pono program, providing minimally processed sweet potatoes, bananas, green papayas, and 'ulu – which transitioned to not only a Harvest of the Month menu item but also a regular part of the school lunch cycle in school year 2019-2020. We firmly believe in serving fresh, locally grown foods in our schools and this bill will make the Act 175 goal of 30% local food in schools by 2030 possible by supporting necessary upgrades and training in cafeterias.

We are living proof not only that farm to school / farm to institution is possible in Hawai'i, but of its huge potential benefit for both local farmers and children. To this day one of the strongest memories I have is standing in a supermarket giving out samples of 'ulu when a little boy excitedly ran up and told his mother how much he knows about and loves 'ulu because he ate at in school. At the same time the partnership between our co-op and DOE had a meaningful impact on the 100 small-scale, diversified, family farmers of the co-op located on both Hawaii island and Maui - by enabling us to expand the number of crops we purchase from farmers and to grow our overall volumes from 20,000 pounds in 2017 to 40,000 pounds in 2018 and nearly 200,000 pounds by 2020. About half of our volume was going to local schools at the pinnacle of this relationship.

This month, we surpassed over 800,000 lbs of produce purchased from local farmers since our inception and we hope to continue to supply this nutritious food to local schools which are equipped with the tools and training to prepare fresh, locally grown foods for students' plates.

Aloha Chair Woodson and Members of the Committee:

My testimony is submitted in my individual capacity as a member of the Hawai'i County Council and Chair of the Hawai'i County Council Climate Resilience and Natural Resource Management Committee.

We support HB1864 HD1which improves the ability of school food programs to serve students fresh, locally grown foods by appropriating funds for school cafeteria upgrades and cafeteria training. School food programs play a critical role in improving health, locally grown food benefits students, small businesses, local farmers, and the environment.

The pilot projects (2016-2018) were overwhelmingly successful. With two months of training, Kohala school complex kitchen staff went from serving processed food to one hundred per cent scratch-cooked food. The efforts of the cafeteria team led to fresh food purchases that increased from a baseline of twenty-seven per cent to ninety-two per cent. This increase coincided with more than \$30,000 in savings and increased student participation in school food programs. Similarly, the 'Āina Pono project at Mililani high school resulted in a savings of \$106,658 over the course of one semester while increasing local and fresh food purchases, student participation, and staff morale.

For the reasons stated above I urge the Committee on Consumer Protection and Commerce to support this measure as well. Should you have any questions, please feel free to contact me at (808) 323-4267.
