The HFFA, on behalf of all of our members, **supports H.B. No. 925, H.D. 1, S.D. 1** which provides for collective bargaining cost items for the members of Unit 11, including the cost of salary adjustments negotiated between the State and HFFA for fiscal biennium 2021-2023. As you know, HFFA members provide fire protection and life safety services at the Airports throughout the State of Hawaii.
