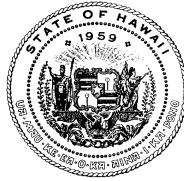
Senate Bill 2172, Senate Draft 1, proposes to: 1) Add a new section to Chapter 342L, Hawai'i Revised Statutes, prohibiting the issuance of permits for new underground fuel storage tanks mauka of the underground injection control line as defined by the Department of Health beginning July 1, 2022; 2) Prohibit operation of and renewal of underground fuel storage tank permits located mauka of the underground injection control line as defined by the Department of Health beginning January 1, 2023; and 3) Define underground fuel storage tank as any fuel tank or tank facility and associated infrastructure that is or includes field constructed tanks, or that has a capacity of over one hundred thousand gallons. **The Department of Land and Natural Resources (Department) supports this measure and offers the following comments.**

The Department is concerned about the risks of underground fuel storage tanks and their related plumbing leaking and contaminating potable drinking water aquifers. The Department and its Commission on Water Resource Management stands united alongside Hawai'i's Congressional delegation, the Hawai'i Department of Health, and the Honolulu Board of Water Supply calling on the Navy to immediately suspend operations at the Red Hill Bulk Fuel Storage Facility and fully comply with the Emergency Order to begin the process of planning and executing the safe removal of fuel that continues to pose a threat to O'ahu's drinking water.

Prohibiting the installation or continuance of underground fuel storage tanks systems *mauka* of the underground injection control line would mitigate this risk. While the underground injection control line is established to protect drinking water aquifers, the Department notes that there may be public trust protected uses like groundwater dependent ecosystems and/or traditional and

customary practices that may be impacted should contamination from underground storage tanks occur *makai* of the UIC line.

1 **Fiscal Implications:** The fiscal implications of this measure are unknown at this time.

2 **Department Testimony:** The Department of Health (department) supports this measure and its  
3 intent to protect the precious freshwater resources of our pae ‘āina. The current version of the bill  
4 goes a significant distance to realize this intent and eliminate the unintended consequences of the  
5 original bill. We offer amendments below to refine the bill language to further clarify intent and  
6 avoid additional unintended consequences.

7 The department’s Underground Storage Tank (UST) program is responsible for  
8 regulating and inspecting all USTs within the state. The program is authorized by chapter 342L,  
9 HRS, and is approved and partially funded by the U.S. Environmental Protection Agency.  
10 Section 342L-1, HRS, defines the program’s foundational concepts “underground storage tank”  
11 and “underground storage tank system” in accordance with federal UST program definitions.  
12 The introduction of a new definition “underground fuel storage tank” to refer only to tanks with a  
13 capacity greater than 100,000 gallons could cause confusion because the term is so similar to the  
14 existing term “underground storage tank.” In addition, USTs can store regulated substances other  
15 than fuel. Potential problems for the program can be easily avoided by changing the new term to  
16 “large capacity underground storage tank system.”

1 We also recommend adding a definition of “underground injection control line” that  
2 points to a specific, existing line. The underground injection control (UIC) line defined in the  
3 offered amendments is the current line defined by the department pursuant to statute (chapter  
4 340E, which we believe is intended to be referenced on page 2 lines 12, 18, and 20). For the  
5 purpose of the prohibitions proposed in this bill, the department believes it is helpful to point  
6 directly to an already-defined line rather than the department’s authority to define such a line.

7 **Offered Amendments:** The Department respectfully offers the following to replace section 2 of  
8 the bill.

9 SECTION 2. Chapter 342L, Hawaii Revised Statutes, is amended by adding a new  
10 section to part I to be appropriately designated and to read as follows:

11 **“§342L- Large capacity underground storage tank systems; prohibited. (a)**  
12 Beginning July 1, 2022, the department shall not issue a permit for a new large capacity  
13 underground storage tank system inland of the underground injection control line; provided that  
14 a permit may be issued by the department for purposes of repairing or removing an existing  
15 underground storage tank.

16 (b) Beginning January 1, 2023, no person shall operate a large capacity underground  
17 storage tank system inland of the underground injection control line, and no permit for a large  
18 capacity underground storage tank system inland of the underground injection control line shall  
19 be renewed.”

20 SECTION 3. Section 342L-1, Hawaii Revised Statutes, is amended by adding two new  
21 definitions to be appropriately inserted and to read as follows:

22 ““Large capacity underground storage tank system” means an underground storage tank  
23 system with any single tank with a capacity greater than 50,000 gallons or with a total tank  
24 capacity greater than 100,000 gallons.”

1           ““Underground injection control line” means the Underground Injection Control line  
2 represented by a dashed line on the “State of Hawaii Department of Health Underground  
3 Injection Control Program” maps, made effective July 6, 1984, and identified as follows:

4           (1) For the island of Hawaii, quadrangles H-1 to H-74;

5           (2) For the island of Kauai, quadrangles K-1 to K-11;

6           (3) For the island of Lanai, quadrangles L-North and L-South;

7           (4) For the island of Maui, quadrangles M-1 to M-17;

8           (5) For the island of Molokai, quadrangles M-East and M-West; and

9           (6) For the island of Oahu, quadrangles O-1 to O-15.””

10          [Renumber existing sections 3 and 4.]

Subject: Senate Bill 2172 SD1: Relating to Underground Storage Tanks

The Honolulu Board of Water Supply (BWS) supports the intent of the bill and offers the following comments for your consideration.

The bill proposes amending Hawaii Revised Statutes (HRS) Section 342L by adding a new section that require, beginning July 1, 2022, the Department of Health not issue a permit for a new underground fuel storage tank mauka of the underground injection control line as defined by the department pursuant to Chapter 342E. The bill also proposes, beginning January 1, 2023, that no person shall operate an underground fuel storage tank mauka of the underground injection control line as defined by the department pursuant to chapter 342E, and no permit for an underground fuel storage tank mauka of the underground injection control line as defined by the department pursuant to chapter 342E shall be renewed.

We believe the bill's citing 342E actually means chapter 340E. Chapter 342E pertains to non-point source pollution. The UIC line is currently defined as the line represented by a dashed line on the State of Hawaii department of health UIC program maps pursuant to HRS chapter 340E which is for protecting drinking water. Revising the bill to cite 340E avoids any intra-agency conflicts that may arise if the UIC line were also cited in chapter 342E. To ensure consistency, we recommend this measure adopt the proposed language in SB2600 SD1 in its entirety.

Mahalo nui loa for the opportunity to testify in **STRONG SUPPORT** of SB2600 SD1 and SB2172 SD1, both of which will help to ensure that our drinking water aquifers are protected from contamination from the Red Hill Bulk Fuel Storage Facility and similar massive underground storage tank systems.

Accordingly, the Sierra Club supports these bills as a means to ensure that we do not repeat the mistakes of the past, in prohibiting the operation of massive underground fuel storage tanks and facilities that may pose an inherent risk to our water and our ways of life here in Hawai'i.

The Sierra Club notes that these measures are substantially similar, and defers to the Committees' judgement as to whether to advance one or both of these bills. **Should the Committees choose to advance SB2172 SD1, the Sierra Club does respectfully recommend changing the references to HRS Chapter 342E on page 2, line 12 and page 2, line 18 to HRS Chapter 340E, as the chapter applicable to underground injection control lines.**

**Statement of the Protect Kaho'olawe 'Ohana  
Regarding the Kapūkakī Fuel Storage Tank Facility  
Calling for the immediate decommissioning and removal of the fuel tanks**

E ui aku ana au iā 'oe:

Aia i hea ka wai a Kāne?

Aia i lalo, i ka honua, i ka wai hū,

I ka wai kau a Kāne me Kanaloa —

He wai puna, he wai e inu,

He wai e mana, he wai e ola.

E ola nō, e-a!

One question I ask of you:

Where flows the water of Kāne?

Deep in the ground, in the gushing spring,

In the ducts of Kāne and Kanaloa,

A well-spring of water, to quaff,

A water of magic power, the water of life!

Life! O give us this life!

The lines quoted above comprise the last stanza of “He Mele No Kāne,” a composition that masterfully describes all of the places that water may be found. From the zenith of the heavens to the depths of the Earth, from the rising to the setting of the sun, water is everywhere. This water is a physical manifestation of the deity Kāne. It is sacred. It is life giving.

In recent weeks, a threat to our life-giving water has reared its menacing head. Officials and activists warned of this potential hazard for years. True to character, the United States Navy is attempting to downplay the seriousness of the issue at hand, just as it did for many years when we fought to stop the bombing of Kaho'olawe. The Navy's lack of integrity and absence of transparency prove that it once again cannot be trusted. The careless abuse of Kaho'olawe and lackadaisical cleanup of the island established precedence of their negligence. We again witness their carelessness and mismanagement of Hawai'i's precious resources.

The fuel storage tanks at Kapūkakī (Red Hill) are a known threat to O'ahu's aquifer. For many years, community groups such as the Sierra Club of Hawai'i and individuals such as Ernest Lau, Board of Water Supply Chief Engineer, cautioned of imminent discharge from the aging fuel tanks that sit over O'ahu's natural volcanic dikes. Yet the Navy continues to deny the

presence of such risk and chooses, instead, to evade the fact that we are on the brink of a devastating environmental disaster. At a December 2, 2021 Facebook Live town hall meeting, 25th Infantry Division Cmdr. Maj. Gen. Joseph Ryan told attendees, “Our readiness posture here in the Pacific is predicated, the foundation of it, is the life, health and safety of our service members and their families.” Is that not telling? It’s not about the island, the environment, and the people of Hawai‘i, it’s about the military families and their assets. And, tragically, the service members and families have been the first to be impacted.

The Protect Kaho‘olawe ‘Ohana supports the efforts of the Sierra Club Hawai‘i, the O‘ahu Water Protectors, Ka‘ohewai, and all other environmental advocacy groups that are calling for the **immediate** shut down and decommissioning of the Kapūkakī (Red Hill) Storage Tank Facility. Our water is too precious a resource to wait any longer to take action.

Of course, this is not the first example of a lack of concern for the source of life, our environment, and our well being. In 1965, the U.S. Navy carried out an “experiment” known as “[Operation Sailor Hat](#)” on Kaho‘olawe. Three 500-ton blasts of explosives created a crater on Kaho‘olawe that, in addition to other long lasting effects, may have cracked the water table, diminishing the island’s ability to support flora and fauna for generations. Was that “experiment” a foreshadowing of things to come? This cannot happen again, yet leaking fuel tanks and a possible explosion within the crater are a reality and may be probable should conditions such as this be allowed to continue.

The PKO strongly urges our members and our supporters to call upon Honolulu City Council members, State Senators and Representatives, and Hawai‘i’s congressional delegation to intervene and call for urgent action regarding the Kapūkakī (Red Hill) Fuel Storage Facility. The U.S. Navy must be held accountable for their blatant disregard for the purity of O‘ahu’s drinking water resources and the safety of O‘ahu’s communities. We cannot allow history to repeat itself and let the Navy get away with their reckless actions. E ola ka wai, e ola ka ‘āina, e ola kākou. Let the water live so that the land may live and so that we may live.

The PKO stands in **strong support** of SB2172 and SB2600 which seeks to protect our islands' most precious resource from fuel contamination. Our water is precious and we all have a duty to protect our islands' source of life for present and future generations. Thank you for your consideration.

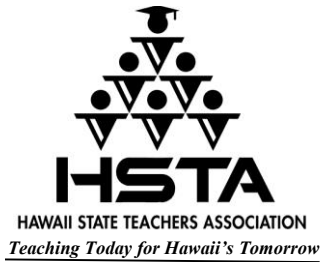

Chair Dela Cruz, Chair Rhoads, and Members of the Committees:

The Hawaii State Teachers Association **strongly supports SB 2172, SD1**, relating to underground fuel storage tanks. This bill prohibits issuance of future underground fuel storage tanks mauka of the underground injection control line as defined by the Department of Health beginning July 1, 2022. Prohibits operation of and renewal of underground fuel storage tank permits located mauka of the underground injection control line as defined by the department of health beginning January 1, 2023. Defines underground fuel storage tank as any fuel tank or tank facility and associated infrastructure that is or includes field constructed tanks, or that has a capacity of over one hundred thousand gallons. (SD1)

**Delegates to the Hawaii State Teachers Association's annual state convention back in 2008 adopted the following policy statement: The Hawaii State Teachers Association believes that every school's drinking water should meet Environmental Protection Agency requirements for clean drinking water.** HSTA further believes that school water should be tested every six months and irregularities should be reported immediately. **More recently, the HSTA Board of Directors unanimously called for the closure and emptying of the Red Hill Bulk Fuel Storage Facility.**

Despite the community coming out in force to support these schools with water donations and school personnel working together to mitigate the impact on students, it has not been easy dealing with this crisis on top of the issues related to the ongoing COVID-19 pandemic. Below is what one Central district teacher earlier this month had to say about everything going on:

"We are more impacted by the tainted water. I am only able to have students wash their hands twice a day with the bulk water they gave us with a pump. I am spending a lot of time outside pumping the water out of the bulk bottle, or

using the individual water bottles to wash their hands. I don't feel comfortable using the spray hand sanitizer we were given to clean their hands. (It doesn't take off food particles, or other dirt and grime from their hands.) They did give some wipes for their hands, but those will be gone soon. I was washing their hands often, but not anymore. The custodians do not clean our desks. So I use the sanitizing wipes to wipe them down daily. Lots of prep time spent to clean the room. We are still not able to use the AC. We are required to keep windows open. Lots of dirt comes in all day. I also get some stray preschoolers come in the back door. The noise is ridiculous. (Airplanes, lawn mowers, other students at recess.) I don't understand how they think we are supposed to get these students up to grade level with all the distractions.”

### **Hawai'i Alliance for Progressive Action Supports: SB2172 SD1**

Aloha Chair Rhoads / Dela-Cruz, Vice Chair Keohokalole / Keith-Agaran and Members of the Committees,

On behalf of the Hawai'i Alliance for Progressive Action (HAPA) I am submitting testimony in support of SB2172 SD1.

The presence of leaky fuel tanks at Red Hill and the Navy's mismanagement of this crisis directly impacts the health and quality of life of Oahu's residents, and will continue to for generations to come. Some of our staff and many of our supporters are directly affected by this crisis. Our water is precious and we all have a duty to protect our islands' source of life for present and future generations.

Mahalo for hearing SB2172 SD1 to prohibit the operation of existing underground storage tanks, as well as the future construction of underground storage tanks within half a mile of an aquifer. SB2172 SD1 seeks to protect our precious drinking water resources and this is of critical importance to our survival.

O'ahu's residents are facing a serious crisis which will continue for years. Board of Water Supply's Ernie Lau said that the Hālawā shaft – which was shut down as a precaution following the Navy's Red Hill well contamination – could be shut down for years, even permanently.

We cannot allow 80-year-old underground storage tanks that store up to 187 million gallons of fuel per day and that pose such an immense threat of leaking and contaminating our environment and water supply to operate 100 feet above O'ahu's sole-source drinking water aquifer.

Navy officials cannot be trusted to protect our water. They have lied time and time again. The following reasons explain why the legislature must act since the Navy has failed to:

- The Navy lied about an active leak at Pearl Harbor for months, discovering the leak in January 2021 but not informing Health Department officials until May. This was revealed in whistleblower emails and documents in October.
- A whistleblower also told the Department of Health in September that Navy officials provided false testimony and withheld information about the full extent of the Facility's infrastructure, including connected pipelines, as well as "historical records of corrosion issues, including holes in tanks" at its Red Hill fuel facility during legal proceedings.
- The Navy suspended use of its Red Hill water shaft on November 28, but the public only found out on December 1. The Navy continues to confuse and gaslight community members.

- Hundreds of community members reported chemical smells in their water on November 28 and then health issues on November 29, which the Navy refused to acknowledge as a potential health concern until the state Department of Health advised residents to not drink the clearly contaminated water.
- A day after the Navy said it had detected diesel in its 'Aiea Hālawā well at levels more than double the DOH safety limit, the military backtracked, saying the contaminated sample "did not come directly" from the well and the Navy does not believe the result proves the well is contaminated.
- They continue to not be transparent despite agreeing to the Administrative Order of Consent, which requires them to be more forthcoming about operations at the Red Hill facility.
- The BWS Hālawā shaft will be shut down until fuel is removed from the tanks and may not reopen for years to come. This shaft was a source of water for South O'ahu from Hālawā to Maunāluā. The BWS has advised that mandatory water conservation measures will now need to be in place in the summer of 2022.
- The Navy "flushed" Red Hill contaminants for days in violation of Department of Health requirements despite repeated warnings. This risked long-lasting effects on birds, plants, fish, and other aquatic life from petroleum contamination

The Department of Health has agreed that the situation is inherently dangerous. DOH said that a water sample taken from the Red Hill drinking water shaft on December 5 confirmed the water is contaminated with "high levels" of petroleum and gasoline. The sample detected total petroleum hydrocarbons diesel range organics levels 350 times above the DOH Environmental Action Level (EAL) for drinking water, and gasoline range organics more than 66 times the DOH EAL.

The Red Hill facility – the fragile, antiquated fuel tanks and supporting systems – has a long history of leaking fuel into the surrounding environment and has already contaminated O'ahu's primary drinking water aquifer. Shutting down Red Hill immediately and entirely is the only way to guarantee the safety of our water and our people.

The Facility's tanks, each with a 12.5 million-gallon capacity, had a quarter-inch thick steel liner when first constructed nearly 80 years ago. They are encased in aging concrete and the steel liners have been corroding to the point where many through-wall holes have been found and in some areas they are one-third of their original thickness.

These tanks have leaked 180,000 gallons of fuel since they were constructed and the Navy's own risk assessment from 2018 concluded that the probability of an acute leak of between 1,000 and 30,000 gallons (independent of any earthquake risk) over the next ten years is 96%. The Navy cannot prove that the tank or tank system will not leak regulated substances into the environment.

Approximately 93,000 people living in military housing have been unable to use their water for over two months. If the Navy water system is further compromised, our housing crisis will mushroom.

Lower levels of petroleum products were also found in samples collected from the Aliamanu Child Development Center as well as homes located on the Navy's water system.

It's absolutely critical that the State Legislature take action immediately to address this major threat to Honolulu's water supply.

Please PASS SB2172 SD1 with the above amendments.

Hawai'i Public Health Institute<sup>i</sup> is in **support of SB 2172, SD1**, which protects public health and O'ahu's clean drinking water supply by prohibiting future construction of underground storage tanks within half a mile of an aquifer beginning July 1, 2022 and the operation of existing underground storage tanks by January 1, 2023.

HIPHI is alarmed by the recent events surrounding Red Hill and the confirmation of petroleum in our water supply. Fresh, clean drinking water is a precious resource, with access to clean drinking water being a basic human right that is "essential for the enjoyment of life and all human rights."<sup>ii</sup>

For years, advocates and organizations like the Sierra Club have warned about the need to protect our drinking water, as the Red Hill Fuel Tank facility sits only 100 feet above the aquifer that supplies water to over 400,000 people, from Hālawā to Hawai'i Kai. The Red Hill facility has a long history of leaking fuel into the surrounding environment and has already contaminated O'ahu's primary drinking water aquifer. Ending operations of the Red Hill facility immediately and preventing future underground storage tanks from being constructed near aquifers is the only way to guarantee the safety of our water and our people.

This public health crisis was preventable, and we urge the Navy and the State to take swift action to protect our water supply. Clean water is essential for life, and access to clean, safe drinking water is a basic human right.

The Environmental Caucus of the Democratic Party of Hawai'i stands in support of SB 2172 SD 1. This measure would prohibit issuance of future underground fuel storage tanks within mauka of the underground injection control line as defined by the Department of Health beginning July 1, 2022. This measure also prohibits operation of and renewal of underground fuel storage tank permits located mauka of the underground injection control line as defined by the department of health beginning January 1, 2023. This measure also defines underground fuel storage tank as any fuel tank or tank facility and associated infrastructure that is or includes field constructed tanks, or that has a capacity of over one hundred thousand gallons. with a capacity of one hundred gallons or more.

In 2018, nearly four years ago, the O'ahu County Democrats, out of dire concern over the risk to the Moanalua-Waimalu Aquifer, our major drinking water source for Moanalua to Hawai'i Kai, affecting hundreds of thousands of residents, businesses and visitors of the Honolulu District, adopted a resolution, OC 2018-11, urging the Navy to retrofit its tanks or move them away from the aquifer. The Navy has taken no such action, and the situation has now become, in the words of your former colleague, U.S. Rep. Kai Kahele, "a crisis of astronomical proportions."

What might have been adequate measures four years ago, e.g., retrofit for double-walled containment, are no longer enough. As the Hearings Officer in the Docket 19-UST-EA-02 Emergency Proceedings between the Navy and the Hawai'i Department of Health concluded last month, the Navy is not capable of competently managing and operating this vast mega-facility. That's why the Navy claims "human error" every time there's a spill. Because Navy staff, who rotate into Hawai'i and then out again in two or three years, and who have inadequate plans and

data to work from, there is a pattern of repeated errors that result in spills that can't be avoided under the Navy's way of doing things.

But the Hearings Officer's decision, affirmed by the State Department of Health, requires gives the Navy to defuel the tanks for "corrective action," but eventually will result in refilling the tanks for an indefinite period. These administrative proceedings will result in no real eventual progress after a brief period of hoped-for "corrective action."

For these reasons, the Environmental Caucus of the Democratic Party of Hawai'i has concluded that we must demand permanent defueling and closure of the facility. Accordingly, the Environmental Caucus supports SB 2172 SD 1 as it would achieve this goal.

The passage of this measure would provide the people of the State of Hawai'i, particularly those residing, working, and visiting the county of Honolulu, a reduced risk of petroleum contamination in its major drinking water aquifer.

'Ahahui o nā Kauka (the Association of Native Hawaiian Physicians) calls for the urgent and permanent removal of the United States Navy's Bulk Fuel Storage Facility at Kapūkakī, commonly referred to as “Red Hill” in modern times. Safe drinking water is the foundation of health for all humans, and in Hawaiian culture carries even more significance as the base for our word for “wealth,” as our ancestors clearly knew people cannot thrive without safe water to nourish our bodies and the land. After decades of warnings about the danger posed by these leaking fuel tanks to sources of drinking water providing for an approximate 400,000 residents of by far the

most populous of our islands, we are dismayed to see that this threat has been allowed to progress to this fulminant crisis where both people and the land are being acutely poisoned by the Navy's persistent contamination at Kapūkakāi.

The fuel storage facility at Kapūkakāi was constructed by the United States Navy, at the time of the crisis of World War II, when its close proximity to a priceless aquifer could have been regarded as insignificant. Some of the liberties taken by the Navy in Hawai'i during this era may have been justified, but the ongoing disregard for our islands and people as little more than military assets since then has presented threats to our health that persist to this day. We are reminded of the 1965 detonation on Kaho'olawe meant to simulate a nuclear blast that cracked the cap rock and permanently destroyed a significant portion of the fresh water to the island, not to mention the continued threat of unexploded ordnance left by the Navy. More than 80 years after construction, it is time for the Navy to acknowledge the extraordinary threat its outdated, dilapidated fuel storage facility at Kapūkakāi poses to our people, land, and ocean.

After over a century of hosting the US Navy's military interests, Hawai'i and its people deserve to be treated as more than military assets left to suffer the harms of infrastructure neglect. As Native Hawaiian physicians, we can no longer turn a blind eye to physical and mental health effects this facility poses to our patients and communities not only by contaminating a large portion of the water supply but also by destroying the faith people had in the safety of our water. We applaud the legislative efforts to address this imminent threat, and prevent the development of future dangerous fuel storage facilities.

As farmers who rely on access to clean, non-petroleum-tainted water, we submit this testimony in STRONG SUPPORT of SB2172, HD1 to further protect O`ahu’s shrinking aquifer from potential future leaks emanating from underground fuel storage tanks. This bill prohibits: A) issuing future large capacity fuel storage tanks “mauka” of an underground injection control line; b) operation of and renewing relevant permits for such fuel storage tanks BUT not effective until July 1, 2050? These prohibitions serve to minimize the risk of leaked fuel contaminating Hawai`i’s diminishing fresh water resources no thanks to the MASSIVE increased development of the Ewa to Kapolei areas and no Koa Ridge on O`ahu.

While we urgently need to prevent future petroleum ingestion tragedies via our water system that so many O`ahu have endured for over a year, the bill -- as originally written -- might create unintended consequences. These included forcing the shutdown of every gas station in the State and impacting the fuel storage for emergency generators at hospitals and other critical locations. Accordingly, some of the amendments and language changes in SD1 make perfect sense to address these concerns, while still ensuring that the State's drinking water resources are protected. However, changing any effective dates to 2050 to either “prohibit underground fuel storage tank operations” [near injection lines] or to “encourage further discussion” is FAR too long to take action to prevent future catastrophes akin to what SO many military families and the general public are experiencing as we submit this. Implementation of all of these changes and prohibitions should occur ideally within the next 3 to 5 years – by 2025 or 2027, at the latest.

Simply put, Ernest Lau, Honolulu Board of Water Supply Manager and Chief Engineer says, "The DOH Hearings Officer at the evidentiary hearing held in December 2021 stated, "the Red Hill Facility, as currently configured and operated, poses an imminent threat to human health and safety of the environment."

The navy's oversight and management of the Red Hill fuel facility has a long history of failures and fuel leaks and proves the navy cannot protect the water from the leaking fuel in its antiquated fuel storage system. This crisis is real and we know it. This crisis has not been resolved and we know it. The military's negligence to adequately maintain it's decaying fuel farm positioned 100 feet above O'ahu's sole-source aquifer is a calamity that has happened several times, and recorded for more than 80 years.
