RELATING TO FOWL

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 2195, S.D. 1, establishes a five-year feral chicken eradication pilot program (FCEPP) within the Department of Health (DOH); requires DOH to submit a special local need registration to the United States Environmental Protection Agency for the use of OvoControl; requires DOH to submit an annual report to the Legislature on the expenditure of funds for the FCEPP and its efficacy of eradicating feral chickens; and appropriates an unspecified amount in general funds in FY 23 to DOH for the FCEPP.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and

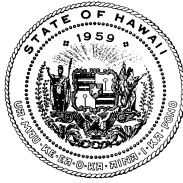
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

Comments:

As the trustee of the Julie Peine Trust that owns multiple apartment buildings and other real estate holdings in Hawaii, we have always worked hard to keep our properties in a neat, clean and well landscaped setting. We feel that by maintaining our properties, it benefits residents and visitors alike as given our island history and culture, keeping Hawaii green and beautiful is important.

Over the years, we've worked diligently to upgrade and landscape our properties by planting ground coverings, trees and plants. It's been an expensive project but we feel well-worth it to ensure we do our part to keep Hawaii green.

Within the past two to three years, however, the feral chicken, rooster and cat population in our neighborhood of Waimalu, Aiea, has exploded to more than 60 feral chickens/roosters around one of our apartment buildings alone! The feral cat issue is equally out of control!

The destruction caused by the cats, roosters and chickens is overwhelming and very expensive to correct. All of our expensive landscaping efforts has been damaged by the roosters/chickens and has led to significant erosion and unnecessary run-off on to the roadway and in to the storm drains. Further, the feral roosters/chickens have presented a major safety issue in that they have foraged under our moss rock walls, brick edging, HECO underground junction box and more, leading to serious safety concerns and risks! It is extremely costly to correct the damages caused by feral fowl, especially knowing that we've done so previously, only to find the damage to reoccur to our landscaped areas.

In addition, the feral cat, rooster and chicken population presents a serious danger to humans, especially when there are chicks, as we've already experienced how aggressive and terrorizing the roosters and chickens can be. Further, there are numerous health issues and risks involved with feral cats, roosters and chickens, especially from the stench and filth of their excrement.

Some organizations have proposed to simply control the feral population by preventing further propagation. Although it's a nice concept, in reality, it's ineffective as it does not prevent the feral population from continuing to forage and cause significant and costly property damage, nor does it minimize the on-going health risks to humans.

Further, the C&C of Honolulu and the State of Hawaii, needs to assertively go back to classifying chickens and rooster as farm animals, irregardless of their quantity, and to not be allowed in residential communities. The constant crowing and cackling has been disruptive to many, especially those who work night-shifts and who try to sleep in during the day, as the chicken/rooster sounds and disturbances go on throughout the morning, afternoon and in to the early evening.

As a Trustee and owner of multiple residential and business properties in Hawaii, our annual real property taxes in Hawaii are in excess of \$40,000. The island business and residential community adversely impacted by this feral animal issue should have a voice and be listened to by our State and City leadership regarding this issue. The feral cat, chicken and rooster population is now out-of-control, continues to adversely impact the upkeep of our properties and continues to lead us to incur further financial costs and expenses in the upkeep of our properties.

The serious issue of feral cats, chickens and roosters is not unique to Waimalu, Aiea, only. This is an island-way, state-wide critical situation, especially in areas such as Waimalu, Makaha Valley Towers, Costco Kapolei and Hawaii Kai and throughout Kaakako.

I urge the Senate to approve this bill and to support the Hawaii residential and business community in our long-standing efforts to eradicate the feral cat, rooster and cat population in Hawaii, state-wide.

Aloha Chair Dela Cruz, Vice Chair Keith-Agaran and Committee Members,

On behalf of the Hawaiian Humane Society, thank you for considering our support for Senate Bill 2195, SD1, which establishes a five-year pilot program within the Department of Health to eradicate feral chickens in the State and makes an appropriation.

Hawaiian Humane has long advocated for the adoption of a birth control program to reduce the population of feral chickens across our state and we are thrilled that the sponsors of SB2195, SD1, and the subject committee chairs have endorsed that approach in this bill. Feral chickens have grown in population largely due to irresponsible behavior by cock fighting operations. Stronger enforcement against those operations is another important strategy to curb this population. For the birds that are already on the landscape, however, mixing contraceptive bait into feed is a more humane and less costly alternative than lethal control.

OvoControl, an approved contraceptive bait to prevent the breeding of pigeons in Hawai'i, is also effective in chickens. SB2195, SD1, does need to be amended to clarify that it is the state Department of Agriculture that has the authority to submit a Special Local Need (SLN) registration to the U.S. Environmental Protection Agency in order to permit OvoControl's use on feral chickens.

We urge you to pass this bill, with our clarifying amendment, and allow public and private landowners across our islands to have a humane option for controlling feral chickens. Mahalo for your consideration.

I strongly support a program to eradicate the feral chicken population, which spans from rural to urban areas. However, I urge amending the bill to establish the program permanently with perhaps pilot funding.

Additionally, please amend to incorporate the following concepts:

- The pilot funding will be most useful to hire a statewide coordinator, or perhaps a coordinator for each county, to work with residents to identify problems (e.g., determining responsibility when nuisance roosters cross property lines, identifying “hot spots” to target, providing education material on rules and resources, etc.). Coordinators should also assist in captures as their time permits. Expedited hiring of the coordinator must be ensured since time is of the essence.
- Allow flexibility in funding so that it can be used in innovative ways, such as to assist local start-up companies and private contractors, or to pay bounties.
- Establish a task force of residents and officials from each level of government to work on programs and policies that further assist in efficiently addressing the problem.

The McCully-Moiliili Neighborhood Board previously adopted resolutions directed at the City and County of Honolulu, but their content should also be considered as part of these State efforts:

For example, on Lokowai Street, Lokowai Place, Kanuku Street and Lii'ipo Street, each area has clusters of feral chickens/roosters, many clusters numbering 50 or more! This is insane and needs to be corrected!

Many residents, myself included, cannot get good nights sleep as the rooster are up in our mango trees and start crowing as early as 3:00 in the morning! Worst, the feral fowl are dirty and leave their droppings, and stench, everywhere!

Further, the feral fowl are destructive! They dig up yards, easements, street-side shoulder areas, gardens, etc.! The feral fowl are even foraging under walls and sidewalks, thus compromising the structural integrity of the structure and leading to serious safety risks!

Simply taking steps to limit the feral fowls' ability to propagate is meaningless and does not address the full scope of the issue, i.e, that the feral fowl is creating damage and are a health and safety risk too!

Senators, the feral fowl population on Oahu and Kauai is now out of control and we need immediate assistance from the State and C&C to eradicate the feral fowl population!

TESTIMONY IN SUPPORT OF SB2195 D

I am tired; tired of trying to keep the feral chickens out of the yard, out of the stable area. These birds are digging holes in our lawn area, making nests in the grass in the horses' stalls, eating the grain leftover from their morning feeding and food for the stable cats (our natural rodent control mechanism). They also stand in the water dishes for the animals. We watch to see that the roosters don't "jump over the fence" of the hens' run so as not to fertilize the eggs we eat.

1. am desperate. We tried trapping them – even to the extent of paying a company to help. My husband tried using bangers to scare them off. am currently using non-toxic plants and spices to the extent possible. But they still keep proliferating.

We tried trapping first, and released them up the valley. We quickly realized however that we were merely making our problem someone else's. We paid a company \$1200 to help us, thinking they would have a better solution. In two weeks, they were successful in trapping 2 juveniles. As for the bangers, it scared the birds for the time following the explosion, but it also excited the horses and goats. Buying/planting, watering the non-toxic plants and spreading spices have added a line to our monthly budget that we can expect to go ad infinitum.

According to the manufacturer of OvoControl, we would be able to see a 50% reduction in number of fowls by the first year and 95% reduction by end of the second year. A short-term investment for a long-term solution seems reasonable.

Studies have repeatedly shown that OvoControl has already proven itself to be highly successful in significantly reducing, or entirely eliminating pigeon populations in many states across the U.S., as well as abroad. In every instance, there have been no adverse effects on the environment; no unintended species, bird or otherwise, were harmed; absolutely no danger to humans, or to communities where it was applied.

Just as importantly, this bill does not focus on the problem. The real nuisance is not chickens, but people. People caused this problem in the first place. How did chickens get out into the larger community? Laws need to be refined so that they actually have teeth. These irresponsible, illegal few should be identified, arrested, and heavily fined. Fines need to be so steep that cockfighting won't be considered a sport worth risking getting caught. Until the legislature puts a stop to the PEOPLE-PROBLEM, we will always have to clean up after the havoc they are continually allowed to wreak in our neighborhoods. Innocent chickens are NOT the root of the problem.

The fact that Ovocontrol will cost Hawaii taxpayers significantly less in both material, as well as labor, makes this method the most reasonable and by far superior choice, over eradication by exorbitantly expensive poisoning, which WILL kill unintended targets, contaminate the environment, and pose harmful risks to humans. In fact, the use of Ovocontrol is far more superior to ANY other means of feral eradication, as this humane approach will not severely traumatize, infuriate, and offend those of us in the community who's consciousness upholds the most sacred and profound respect for all living things.

Although we are animal lovers, feral chickens and rooster belong have created a lot of damage in our neighborhood. They go anywhere they want, into yards, gardens and even swimming pool areas! They forage for food and as a result, have completely destroyed all the gardens and landscaping at our building, Juliana Towers Apartments, as well as at adjacent buildings and properties.

The roosters are a major noise nuisance as they crow from early morning hours to all day and all night and the chickens can be heard cackling from great distances. Myself and many of our neighbors are so upset that we cannot even have an evening, morning or mid-day period of time without the sounds of the chickens/roosters crowing or cackling.

On Lokowai Place, there are about 50 feral fowl running all over the cul de sac; on Kanuku Street, between Lokowai Place and Lii'ipo, there are about 40 feral fowl and in the area of Kanuku Street and Lii'ipo, about 45-50 feral fowl. They have taken over the area and are a serious road hazard as we've often had to swerve to avoid hitting the birds.

The feral fowl issue is so serious that we even looked in to hiring a vendor to catch the feral fowl; however, it was quite pricey and although we were willing to pay the price, what led us to decline the option is that the vendor would not guarantee that they would succeed in catching the feral fowl.

Senators, please pass this bill and we hope you'll start the pilot program in Waimalu, Aiea, as although this problem is state-wide, we feel our neighborhood is totally out of control with the feral fowl (and the count keeps growing weekly!).

Aloha Senators of the Senate Committee on Ways and Means (WAM) who are hearing testimony for SB2195 SD1, Relating to Fowl. Specifically the Feral Rooster/Chicken populations in Aiea.

I am a resident of Aiea, and my family lives above the new Aiea Library, which is located at the Old Sugar Mill location. To say the least, the last few years has been a living nightmare due to the increasing feral rooster/chicken population in our neighborhood. This is a health issue, from all the droppings and fleas from the fowl; a safety concern for cars dodging the fowl as they are on our streets; and a physical, as well as emotional stress from all the crowing at all hours of the day and night!

This started becoming a major problem about 3+ years ago when the feral population became present in our neighborhood, and has subsequently increased. We were told that this began partially when an elderly neighbor was raising chickens in his garage, and many had escaped. The population established, and then exploded along the Aiea stream corridor (which was exasperated by people feeding, as they still are, along the stream), and from there the fowl began to spread to the C&C lot, then the Aiea Library, and then throughout the neighborhoods....

There have been several nests in our front and backyards, as well as our surrounding neighbors yards that we have had to remove; and the excrement is beyond describable! I have also personally seen some extreme safety issues with people walking along Hakina St. almost being hit from cars swerving to miss chickens on the road! Additionally, fleas have greatly increased in our domesticated dogs and cats from the increase in fowl.

Even more disturbing and disrupting is the content clucking of the chickens, and especially the crowing of the roosters at all hours of the day and night! As many of us are now working from home due to COVID 19, this is almost indescribable! The rooster crowing is not the Old McDonald Nursery rhyme; it is high pitch scream like yell at times at all different octaves and sound levels. At night we are constantly, awoken between 11pm-7am! We have even had to invest in double pane windows, and sleep sound machines so we could at least try and mitigate the sound levels of the crowing. The nightly/earlier morning crowing has also developed a hardship for my family. Our 12 year old son is a Type 1 Diabetic, and the constant interrupted sleep cycles from the roosters has negatively affected his blood sugar levels, as well as his schooling from being tired most mornings!

A year and a half ago we saw some relief from the sponsored pest control irradiation of the fowl, but when the funding ended, the fowl along with the associated negative aspects have exponentially increased. I urge you to pass this legislation in order to help to bring back our quiet fowl free community in Aiea
