DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this measure, provides comments, defers to the Office of Wellness & Resilience regarding necessary resources, and requests an amendment exempting the Malama Ohana Working Group from provisions of Part I, Chapter 92, Hawaii Revised Statutes, to facilitate the work of the working group.

PURPOSE: This bill establishes within the Office of Wellness and Resilience the Malama Ohana working group to seek, design, and recommend transformative changes to the State's existing child welfare system and allow the office to contract with an administrative facilitator to provide necessary support for the working group. Requires the Malama Ohana working group to report to the legislature. Appropriates funds. Effective 12/31/2050. (HD1)

The SD1 amended the measure by:

- (1) Inserting a blank appropriation amount;
- (2) Inserting an effective date of December 31, 2050, to encourage further discussion; and

(3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The SD2 further amended the measure by:

- (1) Clarifying that the executive director of EPIC Ohana, Inc. or the executive director's designee and the chief executive officer of Hale Kipa, Inc., or the chief executive director's designee, shall be invited to participate in the working group and serve as co-chairs of the working group; and
- (2) Making technical nonsubstantive amendments for purposes of clarity, consistency, and style.

The HD1 amended the measure by:

- (1) Amending the composition and membership of the Malama Ohana Working Group; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

DHS appreciates the Legislature's and community's efforts to strengthen the child welfare system of care. The system of care involves community advocates, service providers, national and local subject matter experts, DHS, DOH, the Department of Education, the Judiciary, and law enforcement. DHS also works with those we serve; those with lived experience; former foster youth, birth parents, relatives, and resource caregivers.

DHS is a Trauma-Informed Task Force member and actively participates in EPIC 'Ohana Inc.'s Nā Kama a Hāloa network. Alongside community partners, DHS has partnered with community stakeholders to drive this initiative. DHS supports the network and community partner's preference to establish the Malama 'Ohana Working Group within the Office of Wellness and Resilience.

Importantly, given such a large membership and the existing relationships between members, to facilitate the work of the Malama 'Ohana Working Group, DHS respectfully requests an amendment exempting the working group from Part I of Chapter 92, Hawaii Revised Statutes.

Also, through our 'Ohana Nui multigenerational framework to end poverty, DHS is working to improve access to community services and our online capabilities. For example, DHS is working to establish a network of family resource centers as authorized by Act 129, Session Laws of Hawaii 2022, including one at Waiawa Correctional Center as authorized by Act 125, Session Laws of Hawaii, that will serve as a community based one-stop for families to seek services and assistance. Studies have shown that communities with family resource centers have lower rates of child abuse and neglect reports.

We look forward to continuing to innovate with the Office of Wellness & Resilience and the Malama 'Ohana Working Group to address the root causes of child abuse and neglect.

I am writing as an individual, and as the new President & CEO of Hale Kipa, an organization that has served Hawai'i's youth and young adults for 53 years. I completely support the establishment of the Mālama 'Ohana working group.

I am concerned about the families and children in child welfare. Services and resources are stretched, especially on the neighbor islands. Services and resources are needed to deal with issues of domestic violence, substance use disorder, mental health issues, poverty and houselessness. The problems that our children and families face need all of us to work together. We cannot rely on the state government alone. As a member of Nā Kama a Hāloa Network I have witnessed the power of this kind of community collaboration. I served on the Kauhale committee that was able to produce cultural humility and cultural awareness trainings and presentations for CWS workers. We also developed cultural trainings for resource caregivers to help them understand the importance of supporting cultural connections and connecting children under their care to culturally relevant activities and opportunities.

Mālama 'Ohana Working group will engage the voices of those with lived experience as birth parents, youth, resource caregivers and family members both listen to the experiences of overs in the community and come together with community partners and CWS staff to formulate solutions. Thank you for the opportunity to express our **STRONG SUPPORT for Malama 'Ohana.** We are members of the **Nā Kama a Hāloa network**. Nā Kama a Hāloa is a network of more than 30 community serving organizations and individuals with lived experiences that work collaboratively to improve the lives of native Hawaiian children and families in the child welfare system. The network convenes to address and improve the child welfare system by embedding Native Hawaiian approaches and practices in the daily work of those impacting the lives of keiki Hawai'i.

The **Mālama 'Ohana Working Group** was formed and prototyped by the Nā Kama a Hāloa network. Our network asks the legislature to hear the voices of the community to protect the children in and out of the child welfare system. Representation in the working group supports collaboration between service providers with those they serve to lift up the voices of those with lived experience in the child welfare system. We believe that the **Mālama 'Ohana Working Group** is an important commitment and investment to provide necessary lived experience and community recommendations to improve the child welfare system.

We have experienced how helpful and innovative **community collaboration** can be to improving outcomes for children and families. Since 2018, members of the Nā Kama a Hāloa network have worked with leaders from Child Welfare Services (CWS) to implement several projects that shift certain practices of the child welfare system so that it can approach trauma in families in ways that work better for <u>all</u> families and keiki. These collaborative projects include the following samples of our work:

- 1. Developed training for new hires to CWS and resource caregivers.
- 2. Advocated for keeping siblings together.
- 3. Worked on projects that help resource caregivers and birth parents communicate better so that the children are less traumatized.
- 4. Formed a small cadre of parents, known as Parent Partners, with lived experience in the child welfare system that have successfully navigated the system. Parent Partners walk alongside parents to speak about their experiences and help parents navigate the system to improve outcomes for their keiki.

We believe that Native Hawaiian culture-based approaches are prudent and sensible solutions to support the development of all vulnerable youth in Hawai'i, resulting in greater educational, social, health and overall life success.

I am Laurie Arial Tochiki and I am the Executive Director of EPIC 'Ohana. I write to express my strong support and commitment to the Malama Ohana Working Group established by SB 295 as amended. We respectfully ask that an effective date upon signing be established, so that the work can begin quickly. And we ask for an appropriate of \$250,000 for each year of the working group, to be allocated to the Governor's Office on Wellness and Resilience. The working group will begin immediately to establish a collaborative and collective impact design for the working group. Funding is needed for administrative assistance, facilitation, and for report writing. In addition we are proposing the utilization of convenings to air the stories and the ideas that come from listening sessions that will be conducted throughout the state.

EPIC 'Ohana is the backbone organization for Nā Kama a Hāloa. I have been working in the child welfare system for 40 years. First as an attorney representing parents and children in child welfare cases, then as an employee of the Judiciary where I helped to establish programs relating to families and children, including Kids First. In 1996 I was blessed to serve as one of the founders of 'Ohana Conferencing. The system is much more than the Child Welfare Services offices within the Department of Human Services. The system includes all of the organizations that serve the families and children, it includes the Department of Health and the Department of Education, and it includes our communities and those with lived experience in the system. The Mālama 'Ohana proposal will bring together those directly impacted by the child welfare system in a collective impact process that is desperately needed.

Since 2018, Nā Kama a Hāloa, a network of more than 30 organizations and individuals with lived experiences has worked collaboratively to improve the lives of native Hawaiian children and families in the child welfare system. We started with a conversation about the intersection between child welfare and caring for native Hawaiian children who are over represented in the child welfare system. Leaders from child welfare services, Lili'uokalani Trust, Kamehameha Schools, Casey Family Programs and Annie E. Casey Foundation met and affirmed their shared kuleana for the wellbeing of these children. Since then, our network has implemented several

projects to try to shift aspects of the child welfare system so that it can work better. We have developed a training for new hires to CWS and resource caregivers. We have advocated for keeping siblings together, and we have worked on projects to help resource caregivers and birth parents communicate better so that the children are less traumatized. An especially powerful project was to form a small cadre of parents who have lived experience in the child welfare system and have successfully navigated the system. They share experiences of substance use disorder, they are all survivors of domestic violence, and some were formerly incarcerated. Now they walk alongside other parents in the system, and they speak about their experiences to help improve child welfare.

Our network asks the legislature to hear the voices of the community for the urgent need for all of us to work collaboratively to protect the children in and out of the child welfare system. And we as a community must also do more than protect, we also need to care for the wellbeing of the children involved in the system.

We ask that the legislature make a commitment to not only listen to the voices of the families and children, but also enable the joint collective problem solving that this crisis needs. Yes, some of the voices are angry. The conversations will be difficult and must be skillfully facilitated. We collectively grieve for the pain that so many children, parents, foster parents and 'ohana feel not only for the poverty, domestic violence, mental health concerns and substance use disorder issues that make our children vulnerable, but also for the workers in the child welfare system that we believe is in crisis. The only solution is to collaborate.

In January, our HI HOPES leadership boards, made up of current and former foster youth who advocate, educate and collaborate for their brothers and sisters in care, met in Kohala, Hawai'i to strengthen their voices and their leadership for the coming year. A 22 year old young man who aged out of the foster care system said that foster care is like being a broken object, placed on a shelf and forgotten. He shared that he burned his way through seven foster homes before he finally received treatment for trauma. Today he is a solid young man and a leader.

These are the voices we will bring to the table in Mālama 'Ohana. The system is complicated and solutions are not simple. But there is wisdom and genius in these voices, and we ask the legislature to listen. We are deeply committed to this project.

We are writing in support of SB 295, SD2, HD1, relating to child welfare services. This bill establishes within the Office of Wellness and Resilience the Malama Ohana working group to seek, design, and recommend transformative changes to the State's existing child welfare system and allow the office to contract with an administrative facilitator to provide necessary support for the working group. It requires the Malama Ohana working group to report to the legislature.

We represent organizations that serve "opportunity youth," children and young adults under the age of 25 who are disconnected from school and work. Life circumstances, such as low family income, parental absence, neglect, or abuse, can disrupt a youth's ability to fully take advantage of these opportunities. Native Hawaiians are disproportionately represented among opportunity youth. According to a recent point-in-time count, over half of all homeless individuals identified as Native Hawaiian or Pacific Islander, although this group only represents roughly 20 percent of the state's entire population. Of the houseless population counted, 732 are children. This bill has the potential to greatly benefit opportunity youth and, therefore, we support it.

The Opportunity Youth Action Hawaii Hui is a collaboration of organizations and individuals committed to reducing the harmful effects of a punitive incarceration system for youth; promoting equity in the justice system; and improving and increasing resources to address adolescent and young adult mental health needs. We seek to improve the continuity of programs and services for youth and young adults transitioning from minor to adult status; eliminate youth houselessness and housing market discrimination against young adults; and promote and fund more holistic and culturally-informed approaches among public/private agencies serving youth.

The twins wrote for their forensic interview on February 6, 2023, how the dad had been beating both of them, threatening to kill them, many times did not have money for food for them, used drugs, and was about to be homeless with them. My name is Sharla-Ann Fujimoto. I am a resource caregiver in West Hawai'i whose role is to help care for children in the foster care system. I have also been working with foster youth through several non-profit organizations for the last 14 years. I have been the Board Advisor for the HI H.O.P.E.S. Initiative ("Initiative") Youth Leadership Board in West Hawai'i for the last ten years, whose mission is to educate, advocate, and collaborate with community partners on behalf of youth in foster care and to help those transitioning from foster care work towards achieving successful outcomes as adults.

I would like to submit testimony in strong support of Senate Bill 295 SD2 HD1 and its intent to establish the Mālama 'Ohana Working Group within the Office of Wellness and Resilience. The goal of the workgroup is to seek, design, and recommend transformative changes to the State's existing Child Welfare System (CWS) within the Department of Human Services (DHS).

Foster youth are amongst the nation's most vulnerable population. They come into the system by no fault of their own, and they are often left without the much-needed support resources needed as they navigate the system from removal to exiting foster care. This leads them to face poorer outcomes as adults such as homelessness, incarceration, pregnant or parenting at early ages, and overdependence on the public welfare system. Many of these negative outcomes could be avoided if adequate support and resources are provided to foster youth and their parents while their CWS case is still open.

Foster youth, birth parents, resource caregivers, service providers, and the State Social Workers are expected to work together to help the family achieve reunification. However, the enormous difficulty of reaching and engaging the CWS Social Worker paired with high staff turnover / low staffing in CWS offices, inadequate Administrative support, and minimal funding provided to all Child Welfare Services offices statewide makes it nearly impossible to help families achieve reunification within the one year time period they are required to by federal law. This leads to many foster youth being adopted out of care, placed under legal guardianship, or age out of the system at age 18.

Throughout my time working with youth in foster care, I have seen horrific amounts of injustice and harm done to these extremely vulnerable youth. Many of the foster youth I have worked with over the years have shared their frustrations with be because they have no idea what is going on with their case because they've barely seen or heard from their

social worker since removal. Many of these youth have had to fend for themselves to get the things they need, or they just settle to "go without," which is something that no young person should have to experience. Other youth have been horribly mistreated in their resource homes, and when the youth was calling and trying to reach out for help, the only thing they could do was leave a voicemail on an already overloaded answering machine. Birth parents and resource caregivers have very similar experiences of not having any engagement with the social worker, which causes progress to slow down and increases the frustration of all. The point of this is not to place blame on the social workers, but it is to make one thing very clear: foster youth need more support.

As a professional that works with current and former foster youth and as a resource caregiver of several foster children, the Mālama 'Ohana work group will uplift the voices of those with lived experiences (i.e., foster youth and their parents) to help identify the most pressing issues and concerns that plague those that are involved with the System. This work group will also increase the much-needed communication and collaboration between everyone involved to come up with actionable solutions that could help save lives.

We must do better for the keiki (children) of our 'āina (land). My hope is that the success of this project will inspire the citizens of State of Hawai'i to fight for this much needed change in our State's Child Welfare System. In closing, I strongly encourage this committee to support the passage of SB295 SD2 HD1.
