RE: SB 823 SD2 HD1- RELATING TO MOTOR VEHICLE REGISTRATION. PROVIDES AN EXEMPTION FOR FLATBED TRUCKS FROM REGISTRATION RENEWALS AND INITIAL REGISTRATIONS OF MOTOR CARRIER VEHICLES WHEN USED AS MARINE TERMINAL EQUIPMENT TEMPORARILY MOVING IN OR BETWEEN CERTAIN TERMINALS. ADDS NEW TERMINAL LOCALES, TIMES, AND ROADWAYS TO BE COVERED UNDER THE EXEMPTION. EFFECTIVE 6/30/3000. (HD1)

Chair Keohokalole,

My name is Ana Tuiasosopo. I am the District Representative and Trustee for Operating Engineers Local 3. We are the largest construction union in the United States. I and the members of Operating Engineers Local 3 support which expands the existing exemptions or marine terminal equipment moving cargo between terminals. The bill provides an exemption for registration renewals and initial registration for flatbed trucks when used as marine terminal equipment moving within and between certain terminals. The expansion would include new terminal locations and roadways covered under the exemption.

Removing current restrictions would create greater efficiency in the flow of cargo by allowing marine terminal equipment to access new roadways and terminals. We humble ask for your support and approval of SB823 SD2 HD1.
