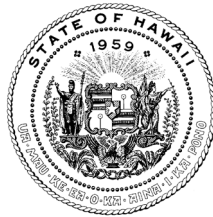

In consideration of
SENATE CONCURRENT RESOLUTION 19/SENATE RESOLUTION 13
REQUESTING THAT JOINT BASE PEARL HARBOR-HICKAM AND THE DIVISION
OF BOATING AND OCEAN RECREATION OF THE DEPARTMENT OF LAND AND
NATURAL RESOURCES COLLABORATE TO ESTABLISH A RECREATIONAL
AREA IN THE EAST LOCH OF PEARL HARBOR.

Senate Concurrent Resolution 19/Senate Resolution 13 requests the Department of Land and Natural Resources (Department) to collaborate with Joint Base Pearl Harbor-Hickam to establish a recreational area in the East Loch of Pearl Harbor. **The Department offers the following comments.**

The Department's Division of Boating and Ocean Recreation (DOBOR) administers the Ocean Recreation Management Area (ORMA) program under Hawaii Administrative Rules Chapter 13-256. DOBOR has authority to designate ORMAs around each of the islands in the State. A designated ORMA contains zones separated by activity type to increase user safety and reduce conflicts. The Department notes that Pearl Harbor waters are under Federal jurisdiction, and the Department therefore defers to any comments and recommendations the United States Navy may provide regarding establishment of a recreational area in the Pearl Harbor East Loch.

The Department also notes that "Neil Blaisdell Park" on Page 2, line 4 is a misspelling and should be spelled "Neal Blaisdell Park."

Thank you for the opportunity to comment on these measures.

RESOLUTION REQUESTING A PUBLIC RECREATIONAL BOATING ZONE IN PEARL HARBOR

WHEREAS, Pearl Harbor is a natural estuary with 4 major lochs, 36 miles of shoreline and approximately 5,000 acres of water surface; and

WHEREAS, Pearl Harbor or Pu'uloa is a cultural, military, and historically significant site for the people of Hawai'i; and

WHEREAS, in 1887 the U.S. government obtained exclusive use of Pearl Harbor ("Harbor") and eventually integrated the harbor has a significant part of U.S. Navy operations in Hawai'i; and

WHEREAS, for more than 30 years, the Pearl Harbor Navy Complex ("Complex") which includes the harbor and surrounding lands (Exhibit A), has been a top priority for the Environmental Protection Agency ("EPA") and the focus of numerous superfund studies and remediation projects; and

WHEREAS, the Navy continues to actively work with the community, the EPA, and the Hawai'i Department of Health to implement long-term dredging, testing, and remediation projects for the Complex area; and

WHEREAS, according to the EPA "there are no immediate threats to human health or the environment at the site"; and

WHEREAS, the City and County of Honolulu's *Primary Urban Plan (2004)* states:

"In the Aiea-Pearl City region, Pearl Harbor's East Loch is a major visual feature and potential recreational asset for the region"; and

WHEREAS, similarly, the *Aiea-Pearl City Livable Communities Plan (2004)* under Future Recreation Projects 2006 - 2025iv includes the following item: "Discuss with the Navy the possibility of limited recreational boating in East Loch from Neal S. Blaisdell Park"; and

WHEREAS, the Navy's Morale, Welfare, Recreation ("MWR") program includes long-standing and successful boating and leisure watercraft activities in Pearl Harbor; and

WHEREAS, the MWR program encourages recreational canoeing, sailing, and kayaking from locations near the East Loch of Pearl Harbor for all military personnel, veterans, Department of Defense employees and their guests; and

WHEREAS, public ocean access and coastal recreational opportunities are of central importance to life in Hawai'i; now, therefore,

BE IT RESOLVED that the Pearl City Neighborhood Board ("Board") supports the establishment of a recreational zone in the East Loch of Pearl Harbor for public boating and other leisure watercraft activities; and

BE IT FURTHER RESOLVED that the Board respectfully requests that the State of Hawai'i and Joint Base Pearl Harbor Hickam Command collaborate to create a public recreational boating zone for the Pearl City community and the people of Hawai'i; and

BE IT FURTHER RESOLVED that the Board acknowledges that to maintain national security in Pearl Harbor the U.S. Navy and Coast Guard regularly evokes security protocols such as patrols vi and that these types of activities may continue with a public recreational zone; and

BE IT FURTHER RESOLVED that the Board encourages the State of Hawai'i's Department of Land and Natural Resources and the City's Department of Parks and Recreation to explore developing small-scale facilities for recreational boating and watercraft activities near the Neil Blaisdell Park and/or the Aiea Bay State Recreation Area; and

BE IT FINALLY RESOLVED that copies of this Resolution be forwarded to Hawai'i's Congressional Delegation, Governor David Ige, Commander, Joint Base Pearl Harbor - Hickam, Commander, U.S. Coast Guard District 14, the State of Hawai'i's Military Liaison, Senator Clarence K. Nishihara and all members of the Public Safety, Intergovernmental, and Military Affairs Committees, Senator Bennette E. Misalucha, Representative Sam Kong and all members of the Corrections, Military, & Veterans Committee, Representative Gregg Takayama, the Chairs and Members of the Aiea Neighborhood Board, Ewa Neighborhood Board, Waianae Neighborhood Board, Kailua Neighborhood Board, and the Waimanalo Neighborhood Board.

The Pearl City Neighborhood Board No. 21 voted at its November 23, 2021 Regular Board meeting, by 9-0-0 vote.



Comments:

Aloha! Honorable Senators and Committee members. Thank you for considering SCR 19. I am Charmaine T. Doran, member of the Pearl City Neighborhood Board No. 21. It is an honor to submit testimony to your committee and on this important matter.

At the end of 2021, our board adopted a resolution requesting that the State work with the Military to establish a public recreation zone in the East Loch of Pearl Harbor. This resolution was prompted after I witnessed sailing, kayaking, and canoeing taking place in the Harbor on a regular basis. Research revealed that this has been the practice for many decades. At one time, the military may have occupied more land on the opposite side of the harbor, but today this is not the case. Today, residents of Pearl City, Aiea, West Loch, Waipahu, and others can walk to the water from City and State parks but cannot enter or use it. They can watch others paddle and sail, but we cannot do the same. Hawai'i has a long and strong history of serving and supporting the military. However, these are antiquated practices that further strain the relationship between Hawai'i's people and the federal government.

In other places such as California, the public is already granted access to the waters fronting and surrounding military bases. It's a simple fix as the military has the power to grant access and establish this type of public zone effortlessly.

We hope that this resolution will help to stimulate a productive conversation. That it will help to prompt other legislative or military acts that will restore public access to the ocean waters in Pearl Harbor. That one day soon, both military children and our keiki can learn to canoe and sail together in the harbor.

A special thank you to Senator Misalucha and others for introducing this measure.

I humbly ask for your support and passage of SCR 19.
