Comments:

Aloha and thank you for giving me the opportunity to submit testimony in support of SCR200.

In 1991 congress ordered that a portion of Dillingham Airfield be returned to the State of Hawaii. There were three stipulations to that turnover of lands.

1. The State and Military Should enter into a joint use agreement for the lands (**Completed**)
2. The land should be surveyed (**Completed**)
3. The secretary should add any additional terms he deems necessary (**Power to expand the Land Transfer**)

In 1995 the land was surveyed specifically for this transfer of land. In 2009 the Army and State of Hawaii agreed to a Joint Use Agreement. Since that time the Army and State have been working to draft documents to complete the land transfer, but it simply has not been a high priority.

The entire Dillingham Military Reservation is over 640 acres. Of that, the Airfield is 287 acres and has been leased to the state since 1962 under a Joint Use Agreement. The west 87 acres in question encompass all the major state-owned infrastructure on the airport, with the notable exception of the eastern portion of the taxiways and runway.

The secretary of the army has the power to expand this turnover of land to include the entire 287 acres of airfield land, and through a joint use agreement would see no change to the Army's ability to complete its mission. This is good for the army because state ownership would enhance DOTs ability to apply for Airport Improvement Program Grants through the FAA resulting in better facilities for their use.

Even if only the west 87 acres is transferred this is still in the State of Hawaii's best interest. Specifically, there is a water system onsite that services Hawaiian residents. If the land was to be in State hands, DOT could officially turnover the water system to Hawaii State Board of Water, removing a conflict with their FAA funding. Currently Hawaii State Board of Water doesn't want to improve and maintain a system that is on land owned by the Army.

All over the country there is a history of Federal Airports being turned over to state governmental bodies. Without going through the long list of precedent, I will just give a great example we have right here at home. The Naval Air Station at Barbers point transferred land to

the State of Hawaii for General Aviation use in 1999. They participate in joint operations and share a continuous runway. There is a water system on site there that services a variety of water users. It was a good deal for everyone, but especially Citizens of Hawaii.

This Resolution is absolutely needed because an act of congress has gone ignored by the State of Hawaii and the Secretary of the Army for thirty years. It has simply not been a priority. This land transfer has the potential to solve all the DOT's named issues at the airfield and to enhance our community's ability to achieve its true potential. Through a Joint Use Agreement, there will be no change whatsoever to the Army's Mission. Moreover, a robust Joint Use Agreement would remove any issue with expanding the land transfer to encompass the entire airfield property, and entire water system, while still leaving more than Half of the Military reservation entirely in Army hands.

The Army and Hawaii DOT are engaged in negotiations for a new Joint Use Agreement right now. Passing this resolution would have an immediate effect on those negotiations.

I support this resolution and thank the Committee for its consideration.

RE: S.C.R. 193 – Conveyance of Dillingham Air Field to State of Hawai`i

Aloha, Chair Nishihara, Vice Chair DeCoite, and Committee Members:

The Ko`olau Foundation offers its support for Senate Concurrent Resolution 200, which would request that the U.S. Secretary of the Army convey Dillingham Airfield – also known as Kawaihapai Airfield - to the State of Hawai`i.

This airfield has not been regularly used by the Army for many years, and instead has been maintained by the Hawai`i State Airports Division as a general aviation airfield since 1962.

Since that time, this airfield has proven to be exceptionally conducive for recreational use for skydiving, glider planes, flight instruction and other general aviation activities, bringing in significant revenue to the State of Hawai`i.

A portion of the airfield property was supposed to have been conveyed to the State of Hawai`i in 1991, but the land transfer was never completed.

This Resolution would call upon the chairperson of the State Department of Land and Natural Resources to work with the Department of Defense to complete all necessary transactions and finalize the conveyance of this land to the State of Hawai`i.

We urge your approval of this Resolution.
