SCR 50 / SR 45

SCR 50/SR 45 designates the Waianae Moku Kupuna Council as an advisory resource to the elected members of the legislature of the State of Hawaii representing the Waianae Moku Community.

The Hawaii State Aha Moku (Aha Moku) supports the intent of this measure and offers comments.

The Hawaii State Aha Moku was created by the Hawaii State Legislature, first in 2007 as Act 212, SLH 2007 and it was updated and finalized in 2012 as Act 288, SLH 2012. The purpose of the Aha Moku is to integrate generational and traditional knowledge of natural and cultural resources of the ahupua'a encompassed by a Moku. Its foundation is based on three traditional principles: Mahalo Ke Akua (Honor God); Mahalo I Ka 'Aina (Honor the land); and Malama I Na Hanau O Ka 'Aina (Honor those born of the land). As such, the traditional designation of a Moku is native Hawaiian although the Hawaii State Aha Moku includes and works with the Public Trust.

The Moku of Waianae already works with the communities of each ahupua'a of Waianae, led by Kupuna. The ahupua'a are: Nanakuli, Lualualei, Waianae, Makaha, Keaau, Hikilolo, Makua, Kahanahaiki and Keawaula who work with State of Hawaii governmental agencies yet are strictly volunteers. As Aha Moku, they are attached to DLNR, but they do not come under its jurisdiction as they are strictly advisory. It is important for legislators to know that this exists. However, we also support any Kupuna 'Aha, or group that exists within a Moku and welcome this collaboration. We already work with many different groups led by Kupuna in Waianae such as the Hawaiian Civic Clubs as an example.

Since names were not listed in SCR 50/SR 45, we believe that at least some of those who are in this new Waianae Moku are probably the same Kupuna in the Hawaii State Aha Moku. We also note that in the Hawaii State Aha Moku, there are no actual councils but the ahupua'a representatives who do make up this 'Aha. These representatives are generational traditional practitioners who are not all native Hawaiian but are traditional practitioners of natural and cultural resources. No ahupua'a representative will make decisions for another ahupua'a. Aha Moku already exist in the other five moku of O'ahu made up of ahupua'a Kupuna.

If this resolution moves forward, will it open the way for all Moku in the state of Hawaii to be formally recognized by the Legislature? The Moku are already recognized by the Hawaiian people. There are 46 traditional Moku in the State which includes Waianae. And, if this happens, will this cause an inadvertent conflict between separate Moku Councils? We have faced this in the past when certain sovereignty groups formed their own Moku Councils with specific Kupuna of their choice.

Thus, we support the intent of SCR 50/ SR45, but have concerns about the make-up, focus and objective of the Council outside of advising elected officials. Do they answer to the ahupua'a they come from? Thank you for the opportunity to comment on our concerns and we do support the wishes of the people of Waianae.
