CALLED 2 Impact has given messages around the world, in four different countries, and all across the state of Hawaii. Through their presentations, CALLED 2 Impact has impacted over 50,000 people.

CALLED 2 Impact understands that the youth are the lifeline of our society here in Hawaii. The youth are the future of healthy communities. Healthy communities build a healthy state, and a healthy state contributes to a healthy nation.

CALLED 2 Impact is Hawaii's only feats of strength group in Hawaii. They bend rebar, break stages of bricks, rip phonebooks in half, all to challenge, encourage, and inspire the youth of Hawaii. List of strength feats done by their bare hands include:

- Bending ½ inch rebar into a U shape
- Breaking a bat over their knee
- Ripping a deck of cards in half
- Ripping a phonebook in half
- Rolling Frying pans into a burrito
- Driving a nail into a frying pan with their palm

- Crushing filled soda cans until they explode
- Breaking staked of bricks in half with their forearm, triceps, and head.

Mark Mauricio is on the CALLED 2 Impact team serving as a resource for illustrations in their presentations. Mark Mauricio have been doing Magic for over 24 years and has a stage show in Waikiki for 17 of those years. He is the only Magician in Hawaii with both a Stage Show and a TV show. His celebrity status and professional sleight of hand aids in students remembering CALLED 2 Impact's presentations that'll go beyond the classroom.


