Description of Request

Hawaii United Okinawa Association's (HUOA) renovation project for the Hawaii Okinawa ("Center") involves significant capital improvements to the 32 yr. old property in Waipio. Operating under original materials and systems for 32 yrs. has taken a toll on the functionality and useful purpose of the center. Prior to the COVID pandemic we were experiencing an annual growth rate of 10% in facility utilization and revenue generation. Since the restrictions have been relaxed business has slowly improved but we're still 20% below pre-pandemic levels in facility usage and revenue generation. We were heading in an upward trajectory pre-covid as we are the primary venue in Central Oahu that can accommodate upwards of 1,000 guest(s). Contributing to this increase has been a rise in private and government business meetings at our facility as we strive to make the venue business friendly. As such, improvements will enable HUOA to continue its mission to Promote, Preserve, and Perpetuate the Okinawan Culture, safely serve the public and be a productive member of the greater community.

The Hawaii United Okinawa Association (HUOA) is a 501 (c)(3) non-profit organization whose mission is to promote, perpetuate and preserve the Okinawan Culture. The organization promotes and practices community service, supports and encourages education, conducts cultural programs, arts and craft exhibits, demonstrations, and athletic and social activities. It prints, publishes and/or distributes Okinawan Cultural and historical information and books. It also encourages its member organizations to sustain their membership and cultural activities that are unique to the individual organizations and international relations.

HUOA is the umbrella organization for its 50 member clubs, whose combined membership exceeds 40,000 members. Members reside mainly in Hawaii, but are also in Okinawa, Japan and the mainland U.S.

HUOA was established in 1951 as the Hawaii Okinawa Rengo Kai, or the Hawaii United Okinawa Association of Hawaii, and renamed the Hawaii United Okinawa Association in 1995.

The Hawaii Okinawa Center (HOC), the home of HUOA, is a 2.5 acre property in Waipio, HI. HOC stands as a living tribute to the Okinawan immigrant pioneers who began arriving in Hawaii in 1990. Encouraged by Governor Jinji Nishime of Okinawa in the 1980's, HOC was built with donations from Hawaii's Okinawan and business communities, and supporters in Okinawa and the mainland U.S. HOC opened its doors in 1990, which marked the 90th anniversary of Okinawan immigration to Hawaii.

HOC also offers the community and state a unique property in Central Oahu to hold meetings, workshops, conferences and special events. It is one the few facilities available to the public that serve the Leeward and Central Oahu region and can stage performances while simultaneously accommodating 1,000 guests. Additionally, families, schools and organizations are able to have small and large functions at this location outside of metropolitan Honolulu. Through HOC the area community continues to flourish with opportunities for small businesses to showcase their products at HUOA events such as:

- Annual Okinawan Festival A two day celebration, whose goal is to "Share Uchinanchu Aloha", is held on the Labor Day weekend at the Hawaii Convention Center since 2018, after spending twenty-five years at Kapiolani Park. A committee consisting of the HUOA Executive Council and club members plan and organize the festival every year. The committee has oversite over 3,500 volunteers who assist in various capacities in areas related to sales, food preparation, cooking, educational displays, video production and overall logistics. The festival attracted approximately 60,000 attendees in 2019 including residents from Oahu, the neighboring islands, the mainland U.S., and even foreign visitors. 2022 marked the 40th year of celebrating and "Sharing Uchinanchu Aloha". Due to COVID-19 restrictions the 2020 and 2021 festivals were conducted virtually.
- Statewide Okinawan Children's Cultural Day Camp Since its inception 1996, HUOA's Children's Okinawan Cultural Day Camp offers children from ages 8 13 yrs. old, an introduction to Okinawan/Japanese culture and Hawaii's plantation history in a fun and enjoyable learning atmosphere at the Hawaii Okinawa Center. This is a four day one-of a kind summer program that began on Oahu and has expanded to the neighbor islands. HUOA clubs on Maui, Hilo, Kona, and Kauai coordinate to offer unique hands-on learning experiences for Hawaii's keiki's to learn about Okinawan Culture and Hawaii's multi-cultural society.

Hawaii/Okinawa International Student Exchange Program – This program
is an annual sister-state exchange program that began in 1990 between the
Okinawa Prefecture Board of Education and the Hawaii Department of
Education, in partnership with the Hawaii State Legislature and HUOA.

Over the past 32 years more than 1,000 students have participated in the exchange program. Okinawa students spend fourteen days on Oahu visiting schools with their host students to explore educational and historical sites throughout the island. Exchange students and their host families enjoy one last gathering at the Hawaii Okinawa Center before returning to Okinawa. Historically, the program received funding from the legislature, with the Hawaii Department of Education responsible to execute the program. Since 2011, funding from the state is no longer available, so HUOA has taken on the task to administer and provide funding to continue this long standing and successful sister-state International Exchange Program.

- Senior Health and Awareness Fair Realizing the needs of our aging community, HUOA began conducting an annual Senior Fair starting in 2011.
 Various vendors offered Leeward and Central Oahu residents an opportunity to meet and learn more about elder care, senior programs, nutrition, retirement facilities, government agencies, financial management, and other senior related concerns in a friendly and safe environment at HOC free of charge.
- Annual Craft Fairs Offering local hand crafters and small businesses an opportunity to showcase their products and services at two Craft Fairs at HOC. The two-day Winter Craft Fair and Evening Craft Fairs offers shoppers an opportunity to patronize over 200 vendors selling their handmade crafts. There's also a separate booth to encourage attendees to donate to Hawaii's Foodbank. This food drive has been successful as we have been able to donate at least a dozen cases of various food items to the foodbank.
- International Partnership for Scholarship & Cultural Exchange HUOA nominates young Okinawans from Hawaii for two scholarships offered by the Okinawan Prefectural Government to study in Okinawa for a period of one year. The close relationship between the Prefectural Government and HUOA offers opportunities for cultural exchange between residents of Hawaii and Okinawa.

Cultural Classes – HUOA supports cultural education by providing classes for Okinawan language, Ikebana(Japanese flower arrangement), Sanshin, (Okinawan string instrument), Taiko and Ichi-Go-Ichie (hybrid instrument of Sanshin and Guitar). Classes are held at HOC by professionals who volunteer as instructors.

- **Sports Programs** HUOA supports a sports program to encourage camaraderie, participation and fellowship amongst member clubs through friendly competition in bowling, golf, softball and volleyball.
- Okinawa Study and Leadership Tour The annual HUOA Study Tour participants experience Okinawa to strengthen ties to Okinawa, provide cultural education and visit Okinawa's Prefectural Government. The HUOA study tour has also provided the opportunity to develop future leaders in the community and in the association. The leadership tour involves representatives from HUOA's member clubs. HUOA, the member clubs, and participant share the cost of this tour which is focused on civic and cultural education.
- Community Service Working closely with homeless shelters on Oahu, HUOA reaches out by holding a picnic and providing much needed clothing, food and the necessities of daily living for shelter residents. During events throughout the year, HUOA accepts donations for Hawaii Foodbank and offers visitors an opportunity to register with Hawaii's Bone Marrow Registry. HUOA provides volunteers for additional events put on by the community.
- Cultural Concerts and Performances HUOA supports and sponsors local and international cultural concerts and performances at HOC. Some of the more noteworthy concerts and performances held at HOC include:
 - Ryukyukoku Matsuri Daiko, an international Taiko/Eisa group celebrated "Ko Ryukyu – Dawn of the Ryukyu's", with performers from Hawaii and Okinawa.
 - Grant "Masandu" Murata Sensei, Ryukyu Koten Afuso-Ryu Ongaku Kenkyuu Choichi Kai Hawaii, shared his solo concert (Dokuen Kai) "Hou On Sha Toku" with many of his followers in Hawaii. Ryukyu Koten Afuso-Ryu Ongaku Kenkyuu Choichi Kai Hawaii performed at Carnegie Hall in New York on April 2019.
 - The Uchinamun Family Variety Show presented their Yaeyama minyo (folk music) to the people of Hawaii on November 2019.
 - Okinawan Festival "Bunkwa Nu Shima" and "Yuimaaru" rooms were filled to capacity with festival attendees watching short performances and demonstrations from our Okinawan visitors. Kimono dressing, musical performances and displays were part of this "Sharing Uchinanchu Aloha".

Hawaii's Okinawan Community is very proud of its heritage and shares Okinawan cultures and values through events like the Okinawan Festival. HUOA programs not only enhance the local community, but have contributed to the socio-economic betterment for the State of Hawaii. HUOA is an integral part of the socio-economic fabric of the State of Hawaii. Upgrading the facilities of the Hawaii Okinawa Center will benefit residents, businesses, and non-profit organizations who regularly patronize the facility.

2. The goals and objectives related to the request;

Current needs that are of priority are projects related to the following:

Accessibility and public safety are critical for our members and users of the facilities. Allowing safe and unimpeded access throughout the facilities are paramount to public enjoyment. As the Hawaii Okinawa Center is thirty-two yrs. old, it is extremely important that each component within the facility is maintained properly and that facilities meet Federal and State safety/accessibility guidelines.

- A partition in the ballroom is designed to separate the ballroom so two functions can be held simultaneously. Presently, after thirty-two years of constant use, maintenance and safety have become primary concerns. Because of its age parts are obsolete which compels us to makeshift some of the repairs which we know is just a temporary fix. This is a very serious safety concern to those who operate the partitions and also to the general public.
- The air conditioning unit for the ballroom has been a constant concern as we have experienced numerous failures to the system. As one could imagine, a ballroom filled with people (capacity is 1,000) with no air conditioning can be very uncomfortable to say the least. Due to its age, the copper condenser coils have deteriorated to the point that the natural elements have taken a toll on the copper itself. To repair leaks that occur our vendor will temporarily spot weld the affected area(s). It is recommended that we replace two condenser coil assemblies or face ongoing failures.
- Our sink in the meeting room, also called the "Chaya", has been in disrepair for several years. At the present time, there is no sufficient area to wash any utensil's which contributes to unhealthy sanitation concerns. The "Chaya" has seen an increase in usage, not only from our HUOA membership but also private groups that request usage of the facility.

The public purpose and need to be served;

The Hawaii Okinawa Center (HOC) is one of the few facilities that serve the Leeward and Central Oahu regions that can accommodate stage performances and banquets simultaneously. HOC provides the surrounding communities a unique facility that can accommodate banquets, meetings, concerts and a stage for the performing arts community. HOC's facilities also host:

- Craft Fairs and Bazaars for local artisans.
- Senior Fairs for Hawaii's aging community.
- Children's Day Camp open to the general public for youths ages 8 13 yrs.
 old. This one week camp is intended to introduce the students to the culture of Okinawa through various games and food offerings.
- Health Fairs sponsored by HMSA and Kaiser Permanente.
- Estate Planning Seminars sponsored by Sterling & Tucker.
- Monthly State of Hawaii Dept. of Education workshops and seminars.
- State of Hawaii public schools' special events such as graduation parties encompassing all grade levels.
- Private school graduation parties.
- Monthly Leeward District Realtors Association meetings.
- State of Hawaii Fire Fighters Association Graduation Ceremony.
- State of Hawaii Sheriff's Graduation Ceremony.
- Miss Hawaii Volunteer Pageant

3. Describe the target population to be served;

The target population is multifold but not limited to the following;

- The Okinawan community in Hawaii.
- Central and Leeward Oahu residents.
- All Hawaii residents who want to explore and learn the Okinawan Culture and Arts.
- Worldwide visitors to our islands that share in the culture programs of HOC, such as the Okinawan Festival and International Concerts.
- People of Okinawan descent or Okinawans-at-heart, community members, individuals and families who desire to promote, preserve and perpetuate their culture through classes and events, and the sharing of knowledge from seniors are the primary population of our programs.
- Patrons and guest(s) who reserve and attend catered events at HOC.

Additionally, these programs and cultural awareness classes have also been shared at the Okinawan Festival to Hawaii residents and visitors from other destinations.

HUOA has been fortunate that it has been able to assist and work with other community and cultural groups within the State and Internationally, thus allowing us to directly target not only our intended population, but to continue to serve groups outside of our primary population. Groups that continuously utilize the facilities include, but not limited to; residents, businesses, organizations and schools of Central, Leeward, and recently the Honolulu district.

4. Describe the geographic coverage.

Hawaii Okinawa Center provides geographic coverage that extends beyond the boundaries of the island of Oahu and HUOA's membership. Membership of over 10,000 households reside not only in Hawaii, but the mainland U.S. and Internationally. The fifty HUOA Member Associations are located on Oahu, the Big Island of Hawaii, Maui and Kauai. International groups from government entities, performing arts, or education sectors choose HOC as a facility to hold events.

V. Experience and Capability

HUOA's Facilities Committee Members are experienced in the fields of Architecture, Engineering, Construction and Property Management, have the required knowledge and skill set to manage the renovation project. Advisors and current committee members were involved in the original fundraising efforts and construction of Hawaii Okinawa Center. This successful campaign raised funds to construct HOC in 1990.

Within the past three years HUOA was awarded, and since executed, major capital improvement projects made possible by the State of Hawaii GIA Program. These improvement projects included stage lighting, sound, acoustic panel and partition replacement which greatly improved the functionality of the banquet hall.

2. Facilities

Opened on June 1990, The Hawaii Okinawa Center sits on a 2.5-acre parcel bordered by Kamehameha Hwy., Uke'e St. and Ka Uka Blvd. in Waipio, Hl. The property consists of two buildings, two gardens, a koi pond and storage.

Both buildings were designed by Maurice H. Yamasato, past President of HUOA, and principal architect of YFH Architects. Almost every feature of HOC reflects the culture and heritage of our ancestors. For example, the center's two turtle shaped buildings symbolize longevity in Okinawan Culture.

Commonly known as the Teruya Building, the Albert T. and Wallace T. Teruya Pavillion, named for the founders of Times Supermarket Ltd., is a multifunction auditorium/theatre and banquet hall featuring a theatre stage and professional lighting and sound system.

Commonly known as the Higa Building, the Yeiko and Kameko Higa Building, named in memory of Zippy's Restaurant founders, Charles and Francis Higa's parents, houses the administrative office of HUOA. A Cultural Gallery and Library is also shared within these spaces with artifacts from Okinawa and Hawaii.

At first glance, the public sees a beautifully maintained property. Thanks to our volunteers, the property has been well maintained. However, upon closer inspection thirty-two years of wear and tear can be seen, most of the fixtures and equipment are original. Additional necessary facility improvements include:

The requested GIA funds will address our needs to provide a safe and secure facility for the general public. Two banquet hall partitions in the banquet hall, which divide the hall so separate functions can be held simultaneously, has been advantageous, not to mention efficient, in utilizing the hall for its intended purpose. Numerous attempts have been made over the years to prolong the useful life of the partitions but it has come to our attention that parts for these 32-year-old partitions are obsolete.

Due to the design of these partitions, it has become a hazard for the employees, and the general public, to operate these partitions. The cables, which allow for the operation of the bottom seal plates, have become frayed and are exposed which is a tripping hazard. Components inside of the partitions are obsolete so we cannot responsibly address any repairs without jeopardizing the integrity of the partition itself.

Issues with an intermittent non-operable air conditioning system in the banquet hall is of utmost concern for the comfort and safety of all guest(s). Having to continuously repair the condenser coils is futile to say the least as total system failure could occur.

The kitchen sink has been a concern, and frankly an embarrassment, due its deteriorated condition. We've had to limit its usage, and even to an extent, shut-off the water supply to render it inoperable due to health concerns.


