Incorporated in 1990 in Hawaii, and we have a USIRS 501- C- 3 IN 1995. I survive on my poverty level Social Security Income. I am the chairperson of the Kalapana Gardens Neighborhood Board and free Community Association.
2. We are in compliance with Section 42-f, Hawaii Revised Statutes
3. I verify that the grant will be used for public purposes. Harry K. Brown County Park road access. Bulldozing @ \$249.00 per hour for a D-9 dozer or \$1,000.00 a day for a D-7 Dozer. From Kalapana Gardens to Harry K. Brown Park. The Community may re-develop the County Park.

BACKGROUND AND SUMMARY

1. My background is: I have worked with my dad. G.C. (Keoki) from infancy. I obtained his Port of Portland position for him when I told my friend Donald McKay Charleson III, "My dad needed a job." When we were in the fourth grade. His dad hired him as he was a board member of the Port. He was hired as an Operating engineer. Dad had just finished working on Grand Coulee, and then Bonneville dams 1939-1945. He went on to complete more projects such as Ice Harbor dam work, extending Portland International Airport, Mock's Bottom Warehouse acreage. Rivergate container shipping area, shipping lane clearance to the ocean. Dad had two titanium, and nylon replacement knees for 30 years, after he retired. For my part, I have developed real estate starting with a house I drafted, had dozed, contracted in 1970-1971. I sold for \$170,000. In 1988. And now is tax assessed for \$750,000.00. Now I build smaller houses, in Kalapana Gardens, Nanawale, Orchidland, and other in the future, if GOD is willing. I have 1 acre for sale in Leilani for \$40,000.00 dozed and has a road, an access apron almost done. Nohea st. Electric is available. It is a quiet, paved road. We may pay someone to take it in us tax refunds. Background of the area is as a handicapped A.D.A. person, I and others need better access to the store at Kaimu. The county has right of way to the park purchased already decades ago. Some day all county road work may be completed for access. However, I may only have a limited amount to spend. First the County Dept. of Transportation needs to survey and mark the county road as they have to Ira 's homesite near the Catholic Church property. The land is all Flat, however, rugged. Those to be served are those in the Kalapana Gardens area. The entire public upon the connection of the county road to the Chain of craters us federal Highway at the West end. Depending on funding, now or in the future. Now many are landlocked, in need of a county road, replaced. The county can asphalt the road when and if motivated. Generously.
- 2.,3.,4. Goal to grant better road access to all those landlocked for over thirty years by cheap and poor government officials. Also to make better road access to the Kaimu Country store for me, an A.D.A. handicapped person at 78 years of age.
5. The geographic coverage is first ½ from Kalapana Gardens to Harry K. Brown Park @ \$100,000.00 and the 2 nd ½ is from Kalapana gardens to the chain of craters federal highway which has been replaced several years ago. @ \$100,000.00. Money left over from 1st ½ may be used to work on 2nd ½. Money left over from the 2nd ½ may be refunded. I can work for free, a voluntary donation, I have always been working class poor.

SUMMARY AND OUTCOMES

1. Scope of work. Work with the department of transportation to paint right of way lines through their survey department. Obtain 3 bids & hire the appropriate bulldozer company.
2. Timelines- depending on funding – Start by October 1, 2023 done to Harry K Brown Park by November 1, 2023. If funds are available - To Chain of Craters federal Highway Start November 2, 2023, and finished by December 1, 2023 ad/ce. , or 2024.
3. I will be on the jobsite. We propose a single lane rough road with no cinders or asphalt. 12' to 15' Wide.
4. I will report to the Hawaii county dept. of transportation, and/ or the Hawaii State department of transportation in all their required ways.
