Kanu o ka 'Āina Learning 'Ohana (KALO), a 501(c)3 since 2000, provides Native Hawaiian education and cultural experiences to Hawaii students from Pre-Kindergarten through adult learners. Pre-kindergarten students are served through Malamapokii Preschool. Kindergarten to 12th graders attending Hawaiian focused charter schools across the state, through in- and out-of-school and summer school programming focusing on educational and socio-emotional well-

being and college and career readiness, to aspiring Hawaii teachers through Kahoiwai Teacher Licensing Program, and for prospective charter school administrators via a Masters in Educational Leadership in partnership with Chaminade University of Honolulu. KALO also adds to Hawaii's educational research agenda by supporting four Ph.D. candidates doing academic research.

KALO programs are accredited through the Western Association of Schools and Colleges, Distance Education Accrediting Commission, and World Indigenous Higher Education Consortium and licensed/contracted by the Hawaii Teacher Standards Board, Hawaii Charter School Commission and Department of Human Services.


Each educational opportunity recognizes and supports the unique cultural and educational prerequisites of Hawaii's children and incorporates multi-generational knowledge and expertise of Native Hawaiian *kupuna* (elders) and cultural practitioners and is open to all students. KALO strives to nurture the needs and passions of students through educational and developmental learning experiences designed to advance the educational and cultural growth of participants.

Since its founding more than twenty years ago, KALO has emerged as a leader for the Hawaiian Focused Charter School (HFCS) movement providing advocacy and legislative support for all seventeen of the state's Hawaiian focused charter schools and the remaining charter schools statewide. KALO was instrumental in establishing an alliance of Hawaiian focused charter schools, Nā Lei Na'auao, sponsoring and facilitating participation of all alliance members, students and parents in annual conferences held on different islands throughout the state. A key component of these conferences includes visits to wahi pana (special places) and community service activities such as clean-up of sacred sites which aligns with project and place-based philosophies that guide Native Hawaiian educational institutions. The annual conferences provide a venue for sharing successes, cultural performances, and facilitating collective decision-making on important issues confronting these schools and communities.

Located in the rural community of Waimea on state lands on the Island of Hawaii, KALO has a diverse range of expertise in the Hawaiian language, cultural revitalization, Indigenous education, community sustainability, and non-profit management. Central to its belief system is a commitment to supporting children by revitalizing Hawaiian culture, language, and traditions and ultimately moving toward thriving communities. For over two decades, KALO has developed and nurtured a family of innovative programs, culturally driven and responsive to community needs through its Pedagogy of Aloha providing culturally relevant, academically rigorous education in a values-based learning environment where learners of all ages are cared for and challenged to meet high expectations.

KALO programs successfully fulfills the purpose and intent of Article X of Hawaii's Constitution by providing for "a Hawaiian education programs consisting of language, culture, and history in the public schools. The use of community expertise shall be encouraged as a suitable and essential means in furtherance of the Hawaiian education program". KALO has benefited Hawaii by directly serving 107,000 participants through its programs. KALO has brought in \$91 million in other than Hawaii general funds, over the past 22 years and disbursed and served all the Hawaiian Islands contributing to the economy and Hawaii education.

CW Associates, CPA's external audit of KALO's financial management have validated through its "Ratio Analysis of Program Service Expenses to Total Expenses" that KALO uses more than 85% of its funding on direct program expenses. Additional audit ratios clarify KALO is a good investment and are available upon request. The graph below shows KALO's direct cumulative reach:



2. The goals and objectives related to the request;

KALO seeks to complete an existing roughed in kitchen space in the multipurpose building as a USDA compliant certified commercial kitchen that meets federal code allowing disparaged populations to receive federal food subsidies to which they are entitled. The current space consists of roughed in area designated for this purpose. Unfortunately, the estimated cost of upgrading the current multipurpose space, \$3million dollars, is beyond our means due to unforeseen inflation, supply chain issues, premium wage requirements and state art required contributions.

Our student population, though eligible for federally subsidized meals, are currently denied access with no USDA approved vender that will service them within 300 miles Students must contend with the services of a commercial lunch wagon with less than healthy meal options that parents must pay for. This is a wrong we hope to correct. Our qualified "free and reduced lunch" children and kupuna deserve healthy meal options for free or at an affordable price.

This project will strengthen and empower the community of South Kohala by providing a USDA approved kitchen within the already constructed Hālau Hoʻokipa, designed to improve the quality of life for low to moderate income community members in Waimea and the surrounding areas by ensuring access to food for disparaged populations by the end of 2025.

Three objectives support this goal:

- 1) To complete the USDA federally approved kitchen within Hālau Hoʻokipa on time and within budget, and;
- 2) Upon completion, to deliver USDA subsidized meals to students and qualifying low-income residents from preschool to kupuna and community members; and
- 3) To provide and avail a commercial kitchen to support innovative student entrepreneurial ventures.

KALO in partnership with Kanu o ka 'Āina New Century Public Charter School's (Kanu) Governing Board is committed to the completion of this project and has reserved funds for part of the cost as well as partnered with the U.S. Department of Agriculture. This GIA request is for \$1,200,000, just under half of the projected cost of the project. Kanu has budgeted \$1,800,000 toward completion.

The public purpose and need to be served;

The Covid-19 pandemic devastated communities across the globe, sparing neither large cities nor rural areas. Our community saw significant job loss, deteriorating mental well-being, educational setbacks, and increased family strife as the pandemic mandated isolation and demolished our economy. In May of 2020, Hawai'i claimed one of the nation's highest unemployment rates at nearly 22 percent and today boasts the highest unemployment rate in the nation at 8.1 percent (U.S. Bureau of Labor Statistics, 2021). Mandated isolation has exacerbated an already tenuous mental health crisis.


Dramatic changes in community well-being and family dynamics will likely have lasting effects on adult and children's mental health as they deal with grief from personal losses, food insecurity, economic hardships, and basic day to day survival. School communities have been profoundly changed. It is vital that educators and Hawaii educational organizations prepare to address the social and emotional well-being of their community of learners and re-focus them on personal growth and emotional health to facilitate a smooth transfer back into safe, secure, and familiar learning environments.

KALO intends to ameliorate the impacts of these adversities utilizing a strengths-based approach incorporating academic and cultural practices implemented through our learning networks across Hawaii. This investment would allow Hawaii proper nutrition for our community, subsidized by the federal government, through our educational programs and services.

4. Describe the target population to be served; and

The service area (Census Track 217.02) is located in the Kohala District delineated in red on the map. A significant beneficiary of this project will be students and families of Kanu o ka 'Āina New Century Public Charter School (KANU), Mālamapōki'i Preschool and Afterschool Program participants. Approximately 70% of the students in this service area qualify for free or reduced meals designed to address the needs of students from low-income families. Our programs currently serve approximately 700 students and 100 staff per day.

KALO's programs serve each island of Hawaii. The target population to be fed will be Waimea-Pu'u Anahulu on the Big Island of Hawaii.

The entire \$1.2 million dollar request will be used for construction and completion of a USDA federally approved certified kitchen within a current community project. The Hālau Hoʻokipa

building houses an 80° x 120° indoor multipurpose space, 32° x 32° of restroom areas, storage space and covered lanai, and a space allocation for a 32° x 122° certified USDA kitchen. As a design-build project, the contractor in tandem with the Project Director will provide project management oversight. The bidding process has already been completed and project management is being done by Quality Builders.

KALO has over 20 years of annual external audits verifying its impeccable money management, organizational capacity, and ability to implement quality programs. This project will address multiple dimensions of well-being by completing facilities needs so programs can be implemented that provide children with academic support, enriching cultural experiences, and college and career-readiness to improve well-being outcomes for Hawaii students, train more teachers, more school leaders and develop more quality research for educators in Hawaii. KALO recognizes the resilience and fortitude of Hawaii students and families throughout the pandemic and hopes to utilize their cultural assets to reduce the adverse impact of the pandemic. By building on community strengths, by engaging students across its network in meaningful activities that lead to thriving, resilient, children and families empowered by a renewed sense of purpose and well-being.

KALO has been in existence since 2000, managed \$119 million in funding for Hawaii, brought in \$91 million in funds to Hawaii and served 107,000 Hawaii residents directly while also planning, developing, and receiving financing for a community learning center called Kauhale. KALO has done the heavy lifting and hopes the legislature is willing to invest in KALO's mission to allow it to further serve Hawaii's communities with educational opportunities. KALO's annual audits with no findings validate its contribution to Hawaii's educational endeavors and attest to KALO's willingness to manage programs, funds, and facilities.

2. Facilities

Lack of adequate physical facilities has been one of KALO's most challenging issues and has seriously hampered its various programs toward reaching its fullest potential. KALO chose to concentrate its efforts on creating new permanent facilities for its current and future programs on a 16-acre portion of Hawaiian Home Lands it occupies. A campus master plan was developed with community input to assure intentional growth and efficient use of existing space. As funding became available, master plan phases were put into place in accordance with identified priorities. All facilities have multiple use, multiple users and serve a wide range of residents and community members realizing KALO's dream to complete and implement quality community resources.

KALO is confident that, with appropriate funding, it will complete the certified kitchen in an efficient, effective manner in accordance with all applicable federal and state laws as well be ADA compliant.

As a veteran member of KALO's leadership team she has comprehensive knowledge of KALO's planning, operational and fiscal resources and is in an excellent position to monitor the work in progress and report back to the stakeholders and Board of Directors. Her successful management of KALO's financial affairs and all facilities development to date is a significant undertaking and one she has handled with expertise and finesse. She has managed three phases of construction on the Kauhale campus, totaling 51,300 sq ft. of facilities at a cost of \$19.5 million. The Project Director is the single point of contact for the project and will be under the direct supervision of KALO's Executive Director.

Architect: Joel Laber of Laber Architects will serve as architect for this project. As project architect he is responsible for the planning, design, preparation, review and execution of facilities plans in accordance with all specifications for design, construction, zoning, building codes, and materials. He will work closely with engineers to ensure the structure meets all safety standards and codes. Mr. Laber is duly licensed and certified to practice in Hawaii. He is ultimately responsible for the project from conception, execution, and successful completion of the job. Mr. Laber is a prominent professional in the field of architecture having completed numerous projects throughout the state.

Contractor: Quality Builders, Inc., founded in 1988 has been in the commercial and residential construction business for over 30 years. Located in Waimea, Hawaii, they have completed commercial projects for North Hawaii Community Hospital, Keck Observatory, Kona Community Hospital, Kohala Hospital, Hawaii Preparatory Academy, Parker School, KALO, West Hawaii Explorations Academy, Kamuela Inn, Ainakea Senior Housing and several service/gas stations. Their work at the HPA Energy Lab in 2010 earned the Living Building Challenge Certification and LEED Platinum certification. Owners Mike Nearman and Sherry Kalaniopio work effectively with clients, problem solve difficult tasks, provide valuable cost savings options, and work diligently to meet all project deadlines. Their experience in commercial and specifically school facilities is an asset to this project.

Fiscal Clerk: Kaohi Ward will be assigned the duties of fiscal clerk for the project. As a member of KALO's fiscal office staff, she has the clerical and accounting skills required for the position. In addition to routine bookkeeping, accounting and purchasing and clerical tasks, she will establish and maintain control accounts, collect budget related data and prepare summarizations for use by the Project Director in preparation of budget and expenditure plans. The fiscal clerk will be under the direct supervision of the Project Director.
