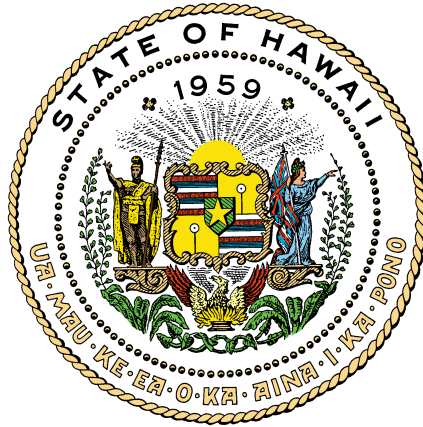

Founded in 1972, KKV has 51 years of experience providing residents of Kalihi with a broad array of comprehensive and holistic care that includes medical, dental, vision, mental health, pharmacy, Elder Care, Maternal Child Health, and enabling services. KKV also provides many culturally based community programs that are integrated with the clinical services. These include four youth programs, women's programs, vocational education, a unique cultural food program "Roots," and Ho'oulu 'Aina, a nature preserve where KKV offers indigenous healing programs, plant-medicine, and education. At Ho'oulu 'Aina, KKV works to heal through community-engaged forest restoration, farming, and agroforestry. KKV's programs have served as models for culturally responsive care, justice, and equity, and malama 'aina/ care for the land.

In 1989, KKV was designated a Federally Qualified Health Center (FQHC) and is the only FQHC in the nation to care for a 100-acre nature preserve as part of its healing sites. KKV provides care for over 11,000 patients annually with a staff of 267 that provides interpretation services in 26 languages and dialects. KKV's patients are 96% Asian, Native Hawaiian, and Pacific Islander; 61% at or below 100% of federal poverty guidelines; and 43% which are best served in languages other than English. We operate

from nine service locations and are the only FQHC in the nation to care for a nature preserve as part of our healing activities. Kokua Kalihi Valley Comprehensive Family Services (KKV) is a community health center with the mission: *“Together we work to advance health, to inspire healing, to foster reconciliation, and to celebrate abundance in the ahupua'a of Kalihi through strong relationships that honor culture and place.”* Kalihi is a Medically Underserved Area (MUA) and a Health Professional Shortage Area (HPSA) for Primary Care, Mental Health, and Dental Care.

KKV's Clinical Director is Dr. Laura Carr DeVilbiss, MD, MPH, who has worked for KKV for more than 24 years. DeVilbiss received her education at Andover, Princeton, Tulane, and the George Washington School of Medicine. She has been active with the Hawaii Academy of Family Physicians, serving in leadership positions on both the HAFP board and the HAFP Foundation board. She has also served on the boards of three local hospitals.

KKV's Executive Director is Dr. David Derauf, MD, MPH, has been with KKV for 31 years. In 1989, he was hired as KKV's first Clinical Director and remained in this position until being named as KKV's Executive Director in 2003. Dr. Derauf worked from 1987-1988 as the Assistant Director of Public Health in the Thai Highland Project on the border of Thailand and Burma. He is board certified in General Preventive Medicine. Dr. Derauf has served as Assistant Clinical Professor of Public Health, Medicine, and Nursing at the University of Hawaii. He serves as a board member of the Association of Asian and Pacific Island Community Health Organizations (AAPCHO), the Hawaii Primary Care Association, and Aloha Care, a Hawaii Medicaid Managed Care Corporation.

2. The goals and objectives related to the request;

KKV seeks funding to conduct a feasibility study to do a large-scale renovation of the Charles Judd Medical Clinic. This facility had inadequate ventilation and space layout to accommodate patients during the COVID-19 pandemic. KKV built a temporary clinic we called Na Koa in the underground parking area that opens to the outside. This has accommodated patients effectively and helped KKV manage an increase in patients and services. But the temporary structure must be taken down in 2022 as per the City & County of Honolulu. KKV desperately needs an after-hours and Urgent Care facility, as well as more space for our mental health programs. The feasibility study will enable us to determine what is possible within the parking garage space, and what structural changes can be made overall to improve functionality of the clinic. In 2023, KKV will renovate the main floor and the third floor of the clinic to update furnishings and fixtures, but we need the feasibility study to understand structural, mechanical, electrical, plumbing, and permit/code issues to move forward with a large-scale renovation.

Goals: To identify the feasibility and cost of a full-scale renovation and expansion of the Judd Medical Clinic.

Objective 1: To meet the needs of patients who walk in to receive medical services in their community.

Objective 2: To make sound financial decisions regarding expansion.

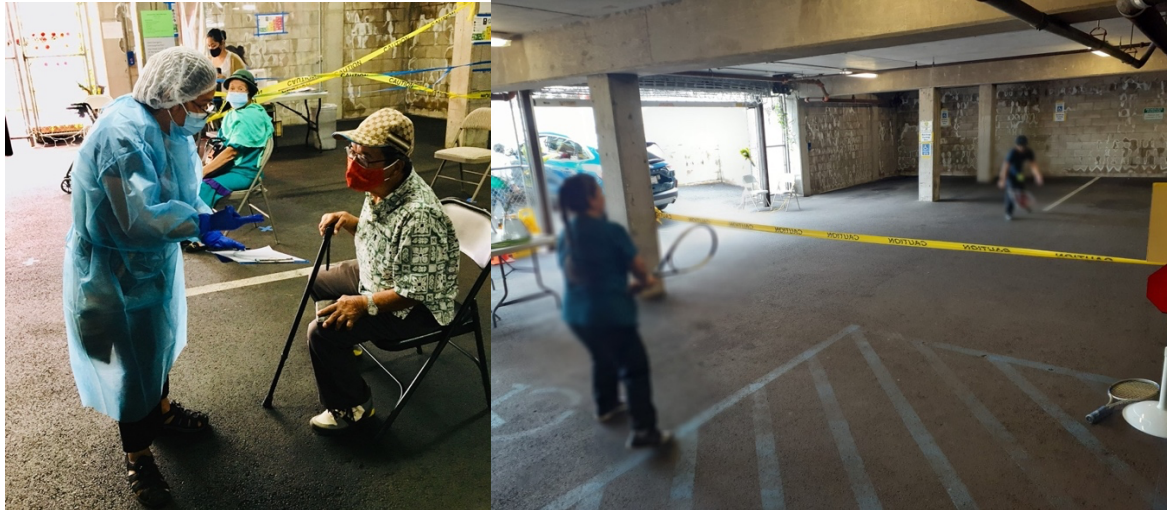
Objective 3: To improve KKV's ability to serve Kalihi residents going forward.

3. The public purpose and need to be served;

Public Purpose:

The purpose of this CIP application is to improve long-term healthcare services for low-income Kalihi residents. Planning now is critical because of the impending redevelopment at Kuhio Park, which will increase the number of residents within blocks of KKV. We anticipate that this will have a significant impact on need for clinical space and urgent care in Kalihi.

KKV will conduct a feasibility study to renovate the Judd Medical clinic at 2239 N. School Street for the purpose of creating an urgent care facility and increased space for mental health services. In 2020, we built a temporary/ emergency COVID clinic in the parking garage under the building. This structure must be removed as per orders by the City & County. KKV desperately needs more space but needs to understand the engineering, traffic, fire, and architectural issues impacting a build out of the garage, especially as it effects structural integrity and functionality of the whole building. The CIP funding will enable us to identify challenges and opportunities before launching a large-scale building campaign.

Need:

KKV’s medical patients have anxiety about medical care and high rates of missed appointments.

Over 93% of KKV’s patients are Asian and Pacific Islander migrants to Hawaii who hold deep distrust of medical care and associate visits to the clinic or the hospital with trauma or death. Many do not seek insurance or care until their condition reaches a crisis stage. KKV experiences a high rate of “no-shows” or missed appointments in part, because many patients are accustomed to walk-in care and less familiar with the process of scheduling appointments. The use of telehealth in 2020 had a surprising benefit in that the no-show rate dropped when some patients received smart phones and could visit with their providers virtually. Additional cultural factors that impact care access include the role of families, extended families, and traditional healers in an individual’s medical decisions; differing cultural attitudes about death and dying that affect “compliance”; the role of physical environment on client comfort and trust; and the effect of American lifestyles and diets on the health of immigrant families. Creating a more welcoming space for patients and their families at the Judd Clinic will be essential to supporting KKV’s patients in a culturally responsive manner.

In 2020 and 2021, COVID-19 impacted API patients at a higher rate than any other communities in the State of Hawaii. Of the 2,865 patients KKV tested for COVID-19, there were 514 positive cases and since many patients live in dense housing, the impact was significant for the larger community. KKV’s Judd Medical Building was not designed to accommodate infectious disease care. Although portions of the building was retrofitted with air filtration systems, other portions were closed off in 2020. Instead of entering the ground floor of the Judd building for medical care, patients were re-routed behind the building to a new temporary clinic (Na Koa) created in an underground parking garage. It was here where KKV moved Eligibility and Billing and conducted COVID-19 testing. This new way of accessing the Judd Clinic has made it clear how much Judd needs a full renovation.

4. Describe the target population to be served; and

KKV serves 11,000 residents of Kalihi who are 96% Asian, Native Hawaiian, and Pacific Islander. Over 30% of KKV’s patients are ages 50 and older and 43% are best served in languages other than English. There are over 1750 seniors currently served by Elder Care, a program that is growing each year. Over 60% of KKV’s patients are at or below 100% of the federal poverty guidelines and 99% are at or below 200% of FPG. KKV’s patients have the highest rates of obesity, diabetes, hypertension, and cancer in the state. We serve residents of Hawaii’s largest public housing complexes, the Towers at Kuhio Park and Kalihi Valley Homes, where the largest populations of residents is COFA Micronesian, Marshallese, Pohnpeian, and Samoan. Many of the migrant families have come to Hawaii seeking health care and experience multiple chronic conditions. Most patients prefer to walk-in to the clinic and building trust relationships with their providers is essential to care.

KKV’s service area is Kalihi and the majority of KKV patients live in zip codes 96819 and 96817. However, KKV serves many patients who move away from the area, with the largest concentrations in 96797, 96701, and 96796.

KKV has the capacity. KKV’s twelve-member Board of Directors oversees our financial position. We have an eight-member Accounting team that monitors all financial transactions, including all grant expenditures. Annually, KKV undertakes a single audit that is comprised of the consolidated statement of financial and the related consolidated statements of activities, functional expenses, and cash flows for the year then ended, and the related notes to the consolidated financial statements. KKV’s management is responsible for the preparation and fair presentation of the consolidated financial statements in accordance with accounting principles generally accepted in the US; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

The CIP project will be directed by KKV’s Chief Operations Officer, Mui Kong who is responsible for ensuring that KKV complies with contracts, including construction and other capital activities. She will hire a Project Coordinator with experience scheduling and coordinating meetings to oversee the tasks are completed on schedule. Kong has over twenty-years-experience in managing nonprofit grants and contracts. KKV plans to work with the architect Kevin Miyamura of AMA/AE who is already working with us on the first-floor renovation activities at Judd.

This project included repairs to side walls and foundation for mold abatement; replacement of the covered front porch; mold abatement in the lower level; creation of two ADA compliant restrooms, including one with a shower facility on the lower level. \$700,000. Funded by: The Hawai‘i State Legislature, Grant-In-Aid 2015; City & County of Honolulu – Community Development Block Grant; and Kahala Nui Foundation. In 2020, KKV replaced the exterior covered walkway and deck \$160,000 (private funding).

In 2008, KKV completed the construction of a 12,000-square-foot health clinic on the site of a former gas station. For the following decade, the Charles Judd Community Health Center—with eight medical exam rooms, six dental operatories, three behavioral health offices, a Maternal and Child Health section, and a large community education room—was the primary home to KKV’s clinical services. 4. *Harry and Jeanette Weinberg Wellness Center*

In 2012, KKV opened its 16,000-square-foot Harry & Jeanette Weinberg Wellness Center across the street from the main Judd clinic. The major renovation effort gutted and converted the former structure (P&P Supermarket) into a Wellness Center that houses 12 state-of-the-art dental operatories and dental operations/outreach office, a commercial kitchen and Roots Café, pharmacy, intake/eligibility, optometry/vision, OB-GYN wing, health education room, Medical-Legal Partnership legal advocacy services, and Administration (Development, Accounting, Patient Intake, Billing). \$8.1 million.

5. *Kalihi Valley Instructional Bike Exchange (KVIBE) Warehouse Renovation*

Renovation of a warehouse to develop programming space for KVIBE and also for KKV storage. Funded by: City & County of Honolulu – Community Development Block Grant 2015. \$270,000.

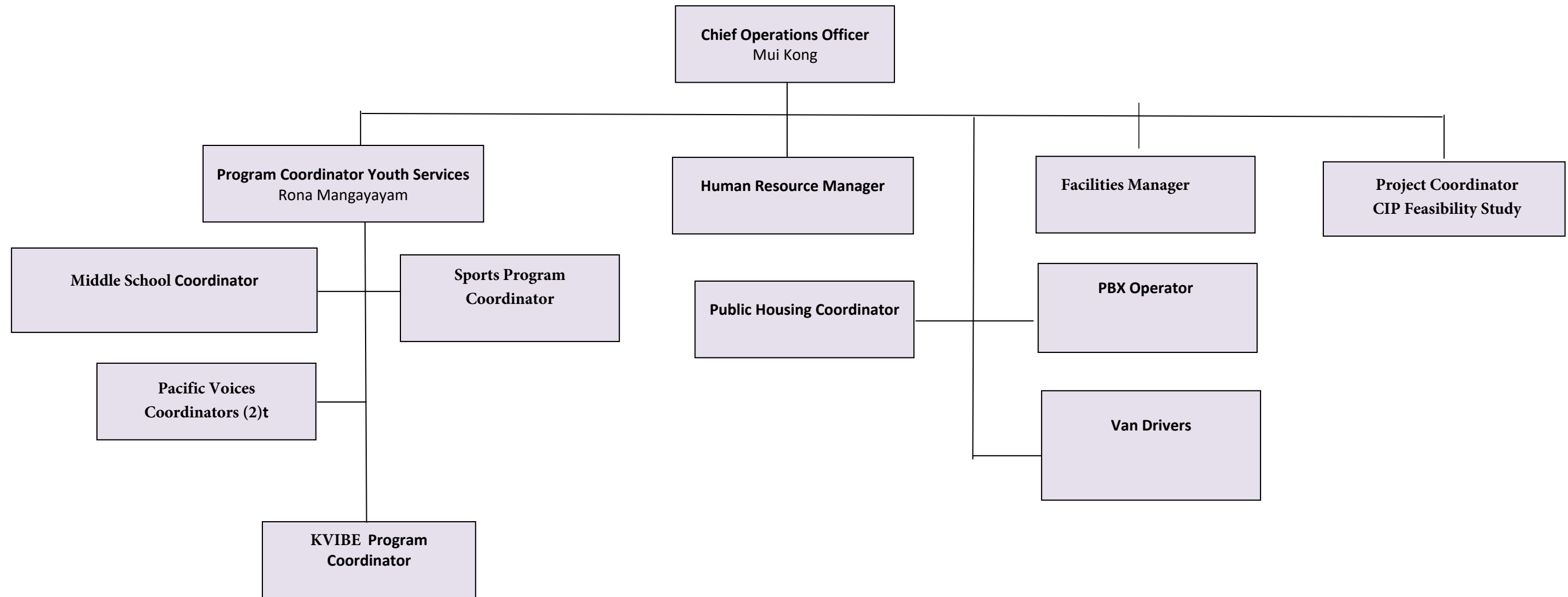
