Section 302A-431, Hawai'i Revised Statutes

Section 302A-431, Hawai'i Revised Statutes, requires the University of Hawai'i to submit a biennial report to the governor and the legislature prior to the convening of each regular session in the first year of each biennium that identifies the cost impacts to the State of providing workers' compensation coverage for students under sections 302A-430 and 302A-440.

Below is a list of claims to the University of Hawai'i for workers' compensation coverage and cost impacts to the state since 2015.

Biennium Year	Provided Workers' Comp Coverage	Cost Impacts
2015-2016	One (1) claim	\$1,046.36 ¹
2017-2018	No claims	\$0
2019-2020	One (1) "Records Only" claim	\$0
2021-2022	No claims	\$0
