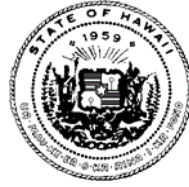

ADDENDUM:

This is an addendum to the legislative report submitted in December 2022<sup>1</sup> responding to Senate Resolution 4, SD 1, Session Laws of Hawaii (SLH) 2022, on conducting a rate study on Home and Community Based Services.

1. After further review, we noted an error in the General Fund calculations in the table (page 4), Estimated Modeled Comparison Rate Impact, and associated narrative summary. Changes are highlighted.

The estimated spend and the general/federal fund estimates show that for the residential services of community care foster family homes (CCFFHs) and expanded adult residential care homes (E-ARCH) that an increase in spending of \$13.5M (\$5.6M A funds), \$27.9M (\$11.56M A funds) and \$30.1M (\$12.57M A funds) for the low, medium, and high rate scenarios, respectively.

The estimated payment increases range from \$23.8M (\$9.86M A fund) to \$40.4M (\$16.74M A funds) for In-home services to \$500k (\$210k A funds) to \$2.3M (\$950k A funds) for case management services. Therefore, the cost to increase all the HCBS Rate study services would range from \$38M (\$15.7M A funds) to \$73M (\$30.21M A funds).

2. We received comments to clarify the one-time pandemic payments allocated in Act 254, SLH 2022 (Act 254):

Act 254 provides one-time pandemic payments allocated for nursing facilities and CCFFHs/E-ARCHs. The rate study does not reflect the one-time pandemic payments because of the

temporary nature of the Act 254 payments. Similarly, the temporary nature of the American Rescue Plan Act (ARPA), which funded capitation rate increases of approximately 5-8%, cited on page 3 of the December 2022 report, is why the rate study does not include the ARPA increases.

The Med-QUEST Division (MQD) is making Act 254 payments in two lump sums. MQD issued the first payment in December 2022, and the second payment will be paid in January or February 2023. The total pool for the one-time pandemic payments was estimated to be 15% of the total amount spent on CCFFHs and E-ARCHs.
