Act 242 Public Charter School Data for School Year 2021-2022

The Commission collected data from all 37 public charter schools for the school year 2021-2022. Note that in the school year 2021-2022, 37 charter schools were in operation across the state. Hawai'i Island was home to 14 charter schools and Kaua'i was home to 5 charter schools. There was one charter school in operation on the island of Maui and another on Moloka'i, while 15 charter schools operated on O'ahu. One charter school operated statewide, one operated on five islands, and another operated on four islands.

While most charter schools have not yet received the training mandated by this new law, all 37 have reported the data requested of them by Act 242. The data is being presented to you in a statewide format as well as by county and school level. Concerns about unintended disclosure or identification of the complainants/victims require the Commission to de-identify the schools as some of our public charter schools have small enrollment counts.
