## A BILL FOR AN ACT

RELATING TO INCARCERATED INDIVIDUALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to amend Act 125, Session Laws of Hawaii 2022, to extend the time to expend 2 appropriations for the establishment of a pilot visitation and 3 family resource center at Waiawa correctional facility on Oahu, 4 and make conforming amendments related to the establishment of 5 the department of corrections and rehabilitation. 6 SECTION 2. Act 125, Session Laws of Hawaii 2022, is 7 amended by amending sections 3 and 4 to read as follows: 8 "SECTION 3. There is appropriated out of the general 9 revenues of the State of Hawaii the sum of \$305,000 or so much 10 thereof as may be necessary for fiscal year 2022-2023 for the 11 establishment of a pilot visitation and family resource center 12 13 at Waiawa correctional facility on Oahu. The sum appropriated shall be expended by the department of 14

9	The sum appropriated shall be expended by the department of
10	public safety or its successor department of corrections and
11	rehabilitation for the purposes of this Act.
12	The appropriation made by this section for fiscal year
