ACT 136

A BILL FOR AN ACT

RELATING TO DEMOGRAPHIC DATA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Asian Americans and 1 2 Native Hawaiians and other Pacific Islanders represent 46.5 per 3 cent of the State's population. While Asian Americans and Native Hawaiians and other Pacific Islanders are often 4 5 misrepresented as a homogeneous group, they are an extremely 6 diverse group, comprising ethnicities from over thirty different 7 countries. Asian American and Native Hawaiian and other Pacific 8 Islander communities in this State experience diverse social, 9 educational, health, and economic differences that are unique to 10 their respective communities.

11 The legislature also finds that, due to this diversity, the 12 United States Office of Management and Budget's Statistical Policy Directive No. 15, entitled "Race and Ethnic Standards for 13 14 Federal Statistics and Administrative Reporting, " separated the 15 "Asian and Pacific Islander" category into two distinct and separate categories, now called "Asians" and "Native Hawaiians 16 17 and Other Pacific Islanders," and these two distinct categories were used in the 2020 United States Census. Census Bureau currently reports data for more than twenty
different ethnicities within these two categories.

3 Despite the federal government's current policy and 4 practice of disaggregating data related to Asian Americans and 5 Native Hawaiians and other Pacific Islanders, not all of 6 Hawaii's state agencies keep demographic data in a standard or 7 uniform manner that comports with these prevailing federal 8 standards. Moreover, most state agencies do not make collected 9 demographic data accessible to the public so that regional and 10 local governments, elected officials, decision makers, and other 11 stakeholders can use the information to strategically target 12 programs for those most in need.

13 Given the diversity of languages and cultures, separating 14 data for Asian American and Native Hawaiian and other Pacific 15 Islander ethnic groups is imperative and making this data 16 publicly accessible is critical for enhancing understanding of 17 the needs and experiences of these different communities. 18 Disaggregating race data for collection, analysis and 19 evaluation, access, and dissemination can aid in shaping 20 programs and policies to advance more equitable outcomes for all communities in the State. 21

1 In particular, the State has unique trust responsibilities 2 with respect to Native Hawaiians, which are administered by a 3 variety of state agencies, including but not limited to the 4 office of Hawaiian affairs. The uniform collection and sharing 5 of data specific to Native Hawaiians is critical to the proper 6 administration of the State's trust responsibilities and 7 improving the conditions of Native Hawaiians through other 8 similar initiatives. 9 The purpose of this Act is to establish a task force on 10 twenty-first century data governance to assess current 11 demographic data collection, processing, retention, and sharing 12 procedures used by, needs of, and challenges faced by all state 13 agencies. 14 SECTION 2. (a) There is established a task force on 15 twenty-first century data governance. 16 (b) The task force shall assess current demographic data 17 collection, processing, retention, and sharing procedures used 18 by, needs of, and challenges faced by all state agencies. 19 (c) The members of the task force shall include: 20 (1) The director of the office of planning and sustainable

development, or the director's designee;
