BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated from the sources of

5 to fund for fiscal biennium 2023-2025 all collective bargaining

7 representative of collective bargaining unit (7):

20 SECTION 14. Funds appropriated or authorized by this Act
 21 that are not expended or encumbered by June 30, 2024, and



1 June 30, 2025, of the respective fiscal years, shall lapse as of
2 those dates.

3 SECTION 15. This Act shall take effect on June 30, 3000.
