# A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to collective bargaining  
4 statewide (BUF 102) the following sums or so much thereof as may  
5 be necessary to fund for fiscal biennium 2023-2025 all  
6 collective bargaining cost items in the agreement negotiated  
7 with the exclusive representative of collective bargaining unit  
8 (9):

1 shall be paid wholly or proportionately, as the case may be,  
2 from the respective funds.

3 SECTION 14. Funds appropriated or authorized by this Act  
4 that are not expended or encumbered by June 30, 2024, and  
5 June 30, 2025, of the respective fiscal years, shall lapse as of  
6 those dates.

7 SECTION 15. This Act shall take effect on June 30, 3000.
