# A BILL FOR AN ACT

RELATING TO VEHICLE SAFETY.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 286-26, Hawaii Revised Statutes, is  
2 amended as follows:

3           1. By amending subsection (e) to read:

4           "(e) Upon application for a certificate of inspection to  
5 be issued for a vehicle or moped, an inspection as prescribed by  
6 the director under subsection (g) shall be conducted on the  
7 vehicle or moped, and if the vehicle or moped is found to be in  
8 a safe operating condition, including adhering to head lamp  
9 requirements and specifications pursuant to section 291-25(a),  
10 as applicable, a certificate of inspection shall be issued upon  
11 payment of a fee to be determined by the director. The  
12 certificate shall state the effective date, the termination  
13 date, the name of the issuing insurance carrier, and the policy  
14 number of the motor vehicle insurance identification card for  
15 the inspected motor vehicle as specified by section 431:10C-107  
16 or state the information contained in the proof of insurance  
17 card as specified by section 431:10G-106. A sticker, authorized



1 by the director, shall be affixed to the vehicle or moped at the  
2 time a certificate of inspection is issued. An inspection  
3 sticker which has been lost, stolen, or destroyed shall be  
4 replaced without reinspection by the inspection station that  
5 issued the original inspection sticker upon presentation of the  
6 current certificate of inspection; provided that the current  
7 certificate of inspection and inspection sticker shall not have  
8 expired at the time the replacement is requested. The director  
9 shall adopt rules to determine the fee for replacement of lost,  
10 stolen, or destroyed inspection stickers."

11 2. By amending subsection (g) to read:

12 "(g) The director of transportation shall adopt necessary  
13 rules for the administration of inspections and the issuance of  
14 certificates of inspection[-]; provided that the rules shall  
15 include head lamp requirements that adhere to the specifications  
16 pursuant to section 291-25(a), as applicable."

17 SECTION 2. The department of transportation shall amend  
18 its rules pursuant to chapter 91, Hawaii Revised Statutes, to  
19 require the owner of a motor vehicle whose motor vehicle  
20 registration and safety check are both expired to:



- 1 (1) Obtain a certificate of inspection pursuant to section  
2 286-26, Hawaii Revised Statutes, without having to  
3 furnish evidence of a motor vehicle registration; and  
4 (2) After obtaining the certificate of inspection,  
5 register the motor vehicle.

6 SECTION 3. Statutory material to be repealed is bracketed  
7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect on June 30, 3000.



**Report Title:**

DOT; Rules; Motor Vehicles; Evidence of Registration;  
Certificate of Inspection; Head Lamps

**Description:**

Requires proper head lamp specifications for vehicle safety inspections. Requires the Department of Transportation to amend its administrative rules to allow motor vehicle owners whose motor vehicle registration and safety inspection are both expired to obtain a motor vehicle safety inspection without evidence of a motor vehicle's registration before registering the motor vehicle. Effective 6/30/3000. (SD1)
